

To obtain a deduction, you can donate more than cash. Gifts of property, such as furniture or an old car, can qualify for the deduction. Yourwrite-off is equal to the fair market value of the property, which is the amount you would receive for the property today from a willing

Making a gift of appreciated property, such as stocks, real estate or antiques, can offer you additional tax benefits. and entertainment and design to improve its' Nevada operations. Circus is not wasting time with it's new corporate strategy; the company cut 33 jobs at it's Laughlin operation, including eighteen at the management level.

Finally, it could be a chilly winter for Mississippi's casino industry. Gambling revenues dropped 5% in August, and surprised the most pessimistic analyst of the states crowded market. Some operators have shut their doors, others see mergers and acquisitions as opportunity. This market appears to be a major disappointment. Other states considering gaming should learn from this lesson.
