(Continued from Page 3) educational issues affecting African-Americans Hispanics. The school board also approved a new position to recruit and hire more African-American and Hispanic

The newly formed committee will begin soon to resolve issues addressed by Unity in the Community.

At the same meeting, the school board came just one vote shy of approving new West Las Vegas schools. The vote was 3-3, with one abstention. One of the group's demands is for the construction of two new elementary schools, a middle school and a high school on the Westside.

Despite the failure of the new

schools proposal, West Las Vegas will still be considered for new schools under a formula being developed that will be used to determine where new schools will be built with 1994 school bond funds.

The possibility also exists that if new schools are not built within West Las Vegas, they will be built nearby.

While the question of building new schools in West Las Vegas remains unanswered for now, improvements to older schools are guaranteed with passage of the bond issue.

There are 111 schools in the Clark County School District that were built before 1986. Forty percent of bond issue funds will be used to remodel older schools and bring them up to new school standards.

All nine elementaries located in West Las Vegas fit into that category and will have 100 percent of their remodeling needs met if both parts of the bond issue are approved. If the total bond issue passes, Westside schools will get \$10.7 million in improvements, including extensive refurbishing (computers, classroom remodeling, new heating and air conditioning systems, rest room renovation) and a host of other facility upgrades.

These improvements are scheduled to be made if both parts of the bond issue pass. In the event only part A passes, or, if both parts fail, there is no guarantee on what improvements, if any, West Las

Vegas schools will get.

In the heat of the moment, untrue statements have been made about how 1988 school bond money was spent. For the record, 94 percent of the square footage and 85 percent of the seats promised in the 1988 school bond program were delivered. In spite of unexpected challenges, which included a sometimes hostile bidding climate, competition with nondistrict construction projects, and increased federal compliance standards, the 1988 school bond program was managed efficiently.

An independent Bond Oversight Committee advises the school board on every aspect of our bond issue. The 19-(See Commentary, Page 28)


