MONEY THE PENSION DELIMMA

If you are married and eligible for a pension from your employer or are self-employed and have a Keogh Plan, you may be faced with a difficult decision regarding your pension benefits when you retire. Some people refer to this decision as the pension dilernma.

Under the provisions of your company's pension plan, you may be required to make an irrevocable selection at or near retirement between the maximum pension benefits for you and no survivor benefits for your spouse and reduced pension benefitS for you with survivor benefits for yourspouse.

For example, suppose you plan to retire at age 62 and are offered the following choices by your company's pension plan:

By selecting the reduced pension benefit of \$28,000 in order to assure that your spouse receives survivor benefits, you sacrifice some of your retirement income each year - \$4,000 annually in this example. Assuming youlive 15 years after retirement, you will have

sacrificed a total of \$60,000 of retirement income (15 years x \$4,000=\$60,000).

Further, if you should outlive your spouse, in most cases you continue to receive the reduced income of \$28,000 for life rather than \$32,000. So in this example, you have given up \$4,000 annually during your retirement, even though you and your spouse never received any actual benefit under the reduced pension benefit. Remember your spouse's survivor benefit under most pension plans is payable only if he/she lives longer than you. Thus, the price to provide survivor income to your spouse can be very high, and it comes during your retirement when you can least
