> KING'S SON ASKS FOR **ECONOMIC EMPOWERMENT FOR** BLACKS

Martin Luther King, speaking on the national holiday honoring his father, said Monday that his father's dream of freedom for blacks would not be fully realized until they also have economic freedom. "We are closer and yet further away from the promised land than we were 30 years ago," Dexter King said during a commemorative service on the national holiday honoring his father, who was assassinated in Memphis in 1968. In perhaps her last "State of the Dream* address, Coretta Scott King, King's widow, said the nation's "compassion deficit" was more important than the government's budget deficit.

A 7,600-square-foot facility which provides cultural services to youths of the West Las Vegas community opened last Friday, January 13. The West Las Vegas Arts Center opened its doors with a host of city and county officials in attendance for the grand opening festivities. The center provides a dance studio, music rehearsal studio, and an arts and crafts workshop.

Located at the intersection of Lake Mead and "H" Street, the target group for the center is youths from the predominantly low-income African-American community. It was jointly funded through the City of Las Vegas and Clark County governments. The \$1.2 million center is considered as a vehicle for cultural expression. It is funded through federal grants from the Community Development Block Grant program. It will be operated by the City of Las Vegas Parks and Leisure Activities Department.

"Youth are the hope of the future. It is appropriate that we begin with them as we look to the revitalization of these neighborhoods," says Clark County Commissioner Yvonne Atkinson Gates about the opening of the facility.

Gates, along with Mayor Jan Jones and Councilmen Frank Hawkins and Ken Brass, supported the project for its cultural benefits to the community. "I'm excited by the many creative opportunities that this center will offer our youth," added the Mayor.

The first effort to bring recently elected public officials back to the community produced a sparse turnout from audience participants, but a significant turnout from politicians. answer questions from the audience regarding follow-through on their campaign commitments. Unity in the Community, an organization which is a combination of several groups throughout the black community, sponsored the event as a method of providing a response to the community from their elected officials.

The organization featured week-long activities inclusive of a community forum the previous evening. Mayor Jan Jones was the keynote speaker for the event. Friday, January 13, Unity in the Community sponsored a community rally and march which stopped traffic en route to the steps of the County Courthouse.

PLEADS NOT GUILTY ST. PAUL, Minn (Reuter) -Malcolm's X's daughter, who as a

child saw her father assassinated in a hail of bullets, pleaded not guilty Wednesday to trying to hire someone to kill his rival, Islamic leader Louis Farrakhan.

She was ordered to stand trial March 22.

In a five-minute appearance before U.S. Magistrate Franklin Noel, Qubilah Shabazz sat silently at a defense table, saying only "not guilty" when the judge asked her how she pleaded.

No actual attempt was ever made on Farrakhan's life.

Famed civil rights lawyer William Kunstler, standing with her, told the court he might file for an extension of some of the pre-trial dates set forth by the court, saying he may need more time for investigation.

He later told reporters "we've formed a legal team. There is no lead
