Discussions about race can sometimes occur in very unlikely settings. That was the case when I attended a professional conference last month in Seattle. There I was sitting attentively with pad and pencil taking notes while a renowned cultural anthropologist made her presentation on trends, conditions and lifestyles that will become commonplace among us in the not-too-distant future.

A gifted speaker who held everyone's rapt attention, she set just the right tone, imparting equal doses of wit, humor and wisdom. And then to everyone's surprise, she suddenly started talking about race. At that point, the audience became quiet. In fact, you could almost hear a pin drop as she shared with us her views on the origin and racial make-up of man.

At one point she flat out said, "There really isn't such a thing as a Caucasian race. It simply doesn't exist." To back up that statement, she listed several books which validate her views.

"Anthropologists have evidence that the oldest living humans are Black and Asian," she said. You have to go a long way forward in time to get anywhere close to when Caucasians first came into the picture."

On what a Caucasian actually is, to the astonishment of the audience, the speaker dramatically stated that, "White people are 65 percent Asian and 35 percent African." To validate this point, she offered as proof the results of genetic decoding, information that is available for anyone to see and review.

She didn't stop there. On the issue of why there is such a wide variation between skin color and features among the world's population, she explained that different racial groups developed appearance traits over hundreds of thousands of years as a way

Another implication is that our preoccupation with race and color is unrealistically based on the ease of visually identifying and mislabeling those of another race as inferior.

In this regard, race is being used as a way to stigmatize certain groups and single them out for unequal treatment. Another implication of what the speaker said is that people are getting wiser about race. More and more people now know that race is a non-issue. And when enough people are exposed to scientific evidence like this, it will have the effect of removing race as an issue so we can get on with the business of living life to its fullest and enjoying it, without the constant threat of negative repercussions because your skin is a certain color.
