This week has been very busy. The NAACP Office has been bombarded with telephone calls. The calls have been from mostly African Americans - from the entire valley. We are appalled at the depiction of an African American person on the cover of the new "Sprint Central Telephone-Nevada First Source Phone Book."

This book covers Las Vegas, Henderson, Boulder City, Blue Diamond, with listings for Cal.-Nev., Ariz., Cotton Wood Cove, Goodsprings, Jean, Laughlin, Mt. Charleston, Nelson, Searchlight and Stateline.

Many African Americans were returning their phone books. We are not satisfied with the awful picture of that so-called Black person. This drawing does not in any way characterize African Americans. To add insult to injury, 4th and 5th grade students drew better pictures than this 11th grade Cheyenne HS Student!

I am certain that Alisa Ochoa has had a great deal of contact with African Americans at Cheyenne HS, and none of those she has seen in any way resembles the picture she has drawn. Everyone in this picture has a human identity except the African American. The girl standing even resembles Miss Ochoa. But can you guess what that "thing" is on "its" knees with the red shirt on?

Some of the things people are calling this office and asking are:

- Is it a boy or a girl?
- Why the pickaninny appearance?
- Why do the whites look clean, neat and sturdy, while the Black child looks dirty and wild?
 The list goes on...

Mrs. Marzette Lewis and I met with Representatives of central Telephone Company on

Now to the Contest Judges: I would like to know where your expertise lies. I do not believe that any of you, Ms. Sue Fink, Ms. Teresa Logan or Dr. Paul Hesselink, have ever seen an African- American who looked like this depiction. We were told that judgeshad to have autonomy. They had very little input, if any, in the selection. Furthermore, they had not viewed the picture in such a light as we have.

We, Mrs. Lewis and I, assured them that it's hard to judge if you don't have the same perspective. In other words, "you can't adequately judge a man until you have walked in his shoes." It appeared that there was no sensitivity taken in consideration of the person of color being depicted in this painting.

Prior to leaving the meeting, it was agreed upon that an article would be written to apologize to the African-American Community if any were affended because of this drawing.

Death Penalty Can't Stop Violent Crime; The American People Can

Recently, New York State Governor George Pataki signed a death penalty bill, restoring capital punishment after nearly 20 years. This was Governor Pataki's big campaign promise — to make New York tougher on crime by making the most heinous murders punishable by death.

It's certainly true that more and more people - white and Black - have come to believe that the death penalty is in no way a deterrent, it has become more popular as a "solution." Why? In my view, it is because most people feel powerless in the face of rising crime and violence and the death penalty seems like something to do that might make a difference. It isn't. But the politicians have deftly capitalized on the public's fear and anger at being so important. Many believe support for the death penalty was a key to Pataki's victory over Mario Cuomo in New York. And on a national level, the Democratic-sponsored Clinton Crime Bill, which passed last year with Republican support, identified 60 new crimes for which Americans could be executed. Both crime and violence or for changing the conditions which produce them.

While I am completely sympathetic to the lack of trust in liberal solutions (prison rehabilitation has been one of the most monumental social policy failures of this century), I do not believe that capital punishment is the answer. I have always opposed the death

penalty and still do. Study after study proves conclusively that capital punishment does not act as a deterrent to murder or any other violent crime. But the death penalty does have a huge impact on the Black community. Thanks to the racist nature of the American judicial system, no white person has ever been executed for killing a Black Moreover, a disproportionately high number of those on Death Row are men of color. In many ways the African American community was condemned to death long Endemic poverty, unemployment, poor education,

drugs and the day-to-day abuse and violence of racism are built into American society.

Ironically, the rise of violent crime and the increased popularity of the death penalty share a similar cause: powerlessness. Unable to make a life for themselves due to economic, social and/or psychological instability, and powerless to change these conditions, some turn to violent crimes.
