

Another equally telling thing was the fact that she revealed that the average cost for a U.S. Senate race is between 4 and 12 million dollars. However, she also made it clear that it is possible with a people's movement to build large numbers of people who will then be able to contribute small amounts of money, and small amounts of money multiplied by large amounts of people adds up to large amounts of money.

Perhaps the most important thing that she said was something that Jesse Jackson also articulated when he was running for U.S. President: Even though they may be the lone person crying in the wilderness (as it were), by having someone in the race (even more so if they win), they do have the ability to change the nature of the debate going on in any legislative body, whether it is the U.S. Senate, the U.S. House of Representatives, state or local legislative body.
