Asked if he was concerned about how his body would react to being punched hard following his four-year layoff, he replied with a smile, "I haven't been hit too much when I have been fighting."

On strategy for his comeback fight with unheralded Peter McNeeley, Tyson said, "I am going to do my thing, and you know what my thing is."

Following in the footsteps of Muhammad Ali, Tyson, who converted to Islam while in jail, said he intended to adopt a Moslem name eventually but would not say when.

McNeeley, who will fight Tyson at the MGM Grand hotel, has a 36-1 record, amassed against little-known opponents.

King defended his decision to put McNeeley in the ring with Tyson, calling him "a worthy opponent."

McNeeley will have by far his

biggest payday for stepping out of obscurity to meet Tyson. He will receive a reported \$700,000, while Tyson pulls in just under \$6 million.

Of Tyson, King said: "Mike is already the people's champion around the world.

"What we are launching today is a campaign for the undisputed heavyweight championship of the world."

In his inimitable fashion, the flamboyant King took over the proceedings, launching into an hour-long monologue replete with old jokes and exhortations to a worldwide television audience to ante up \$50 per household to watch the fight on pay-per-vew television.

At one point, reporters got a glimpse of an even quieter side of Tyson. The former champion appeared so bored by King's ramblings that he yawned visibly, closed his eyes and rested his head on the dais. LAS VEGAS - Mike Tyson faced the news media Wednesday in a news conference designed to drum up publicity for the former world heavyweight boxing champion's comeback fight Saturday against unheralded Peter McNeeley.

Tyson sparred with reporters, explained how Islam has changed his view of life and, at one point, even rebuked his promoter, Don King.

During an answer to a question, Tyson was interrupted by King, whom Tyson had been content in the past to let dominate his public appearances.

With hands raised in exasperation, Tyson turned his head toward King at the podium and said: "Please be quiet when I'm talking."

Tyson predicted he would knock out McNeeley in Tyson's first ring battle in more than four years, following three years in prison for rape.

Tyson responded to various questions about the scheduled 10-round fight, for which he is a 17-1 favorite. He referred to boxing as "my calling from God. This is what I do. This is what I'm interested in doing."

One reporter sparked Tyson's anger. The reporter asked the former champion if he had said that he believes that the people closest to him would betray him one day.

"I said what I wanted to say and that's what I feel and the other reasons why I go back (to


