Speeding Fines In School Zones To Double

....

Las Vegas Municipal Court has announced that beginning Monday, August 28, 1995, traffic offenders found guilty of driving twice the speed limit in a school zone will automatically be fined a minimum of \$500 and be charged a \$100 Administrative Assessment fee. The speed limit for an area designated as a school zone, or school crossing zone ranges from 15 miles to 25 miles per hour. Those exceeding the speed limit by less than double, will pay \$12 a mile instead of the \$6 a mile for every mile over the limit charged in non-school zone areas. Also, Administrative Assessment fees will be charged in addition to a base fine.

"Children will be excited and unpredictable; we're warning the driving public to slow down, obey school zone speed limits, and be especially alert and cautious," Chief Judge Seymore Brown said.
