## **NBA-Dissident Players Still** Oppose Deal, Want Union Dissolved

CHICAGO - A group of dissident National Basketball Association players said on Wednesday they find the latest collective bargaining agreement proposal worked out between the league and its union to be unacceptable and they will continue in their effort to have the union decertified.

"We still feel that this deal is not sufficient enough to stop the decertification effort," New York Knicks centre Patrick Ewing told a news conference here.

Among the objections the players have to the agreement, the second worked out between the league and its union this summer, are that it eliminates most exemptions to the league's salary cap and limits salary increases, said Jeff Kessler, attorney for the players seeking to dissolve the union.

Kessler said players were also dissatisfied that group licensing rights remain with the

Under the agreement "free agency is almost eliminated," Kessler said.

But in a separate news conference NBA Commissioner David Stern said players will be eligible for unlimited free agency after three years in the league and that the league's salary cap would rise to \$32 million from \$23 million.

Stern said those concessions were among the trade-offs NBA team owners gave in return for elimination of most exceptions to the salary cap and the imposition of a limit on salaries for first-year players.

"We tightened the cap, no question about that," Stern said in a teleconference following the players' news conference.

The owners have imposed a lock-out on players that threatens the upcoming NBA season.

But Stern said he believes support for the decertification effort is "dwindling" and predicted "There will be a season."

the next 20 days. The NationI Labour Relations Board scheduled voting for August 30 and September 7. Ballots will not be counted by the NLRB until September 12.

About 400 players will vote in the decertification process, with a simple majority determining whether the union would be stripped of its powers.

The union news conference was attended by more than 30 players either in person or by telephone. Some players met with Kessler and others involved in the decertification effort before the news conference.

The Chicago Bulls' Michael Jordan, who guit a brief foray into baseball when that sport shut down in a contract dispute, said the threat of an interruption of the NBA season should not force players to accept the

"I don't think that's in the best interest of the league," Jordan said in response to reporters' questions by telephone. Players also rejected the notion that they were being forced to rebel against the agreement by their agents who could lose lucrative commissions if a limit is placed on salaries of first-year players.

"I wasn't brainwashed. I wasn't misinformed. I made my own decision," said Charlotte Hornets centre Alonzo Mourning.

"This is an attempt to kidnap our contract," Stern said.



## Gooden's Request For Reinstatement Denied

Dwight Gooden's request to be reinstated to baseball this season has been rejected by acting commissioner Bud Selig.

Selig refused to shorten Gooden's one-year suspension, sighting the fact that there are only six weeks left this season and Gooden would be better served to keep working on his aftercare program.

"I know it was a tough decision for him (Selig), but that means I'll just keep working even harder to make it back next year," the former New York Mets pitcher told the Bergen (New Jersey) Record.

Gooden has been throwing regularly and is considering playing in the Dominican Republic this winter.

"If I was allowed back this year, the Yankees would've won," he said.

Gooden, who initially underwent drug rehabilitation in 1987, was suspended last June for testing positive for cocaine. He was suspended again in September for the entire 1995 season for violating his aftercare program.

Gooden, the National League Cy Young Award winner with a 24-4 record in 1985, was 3-4
