October is National Disability Employment Awareness Month

CARSON CITY — October is national Disability Employment Awareness Month. This annual observance, proclaimed by both President Bill Clinton, and Governor Bob Miller, is designed to bring awareness to all Nevadans, employers and workers, of the value that providing employment opportunities to people with disabilities can bring to any business.

However, rather than focusing on the occasion for just

a month the Department of Employment, Training and Rehabilitation (DETR) works year-round to make significant employer/worker matches. Employers who hire individuals with disabilities and disabled workers are an excellent partnership, "A win-win opportunity for business and labor," said Carol Jackson, DETR director.

Jackson said, the department and its statewide network of offices, annually observes October, as National Disability Employment Awareness Month to heighten awareness of the abilities of disabled workers as employees. "We encourage anyone with a disability to take advantage of the numerous nofee programs and services offered by the department to help put their abilities to work in Nevada's labor force. And, we encourage employers to explore the value of hiring workers with employment disabilities."

"When an able person with a disability comes into one of our offices seeking help to join the labor force we look at their abilities and explore all existing opportunities with them," Jackson said. "Our staff offers employment, training and rehabilitative services so Nevada's disabled workers can excel and become a powerful force in the workplace."


Jackson said, employment disabilities are varied, and can be defined as causing mild -to severe difficulties in daily activities such as walking, talking, seeing, hearing, communicating, and learning. She pointed out that there are more than 67,000 Nevadans with employment disabilities. Nearly half of those people are working — but many more are capable and willing to become a viable segment of the work force.


Home Buyers Seminar
