with Lloyds of London, the British based insurance giant, for what was termed "non-refundable training expenses" paid to Chavez, the world champion. King allegedly lied when he said the fees were not refundable.

If convicted, the 62-year-old King could receive up to five years in prison and up to \$250,000 in fines on each of the nine counts. King was sent to prison in the late 1960s after being convicted on

manslaughter charges. The IRS also is investigating allegations that King helped

foreign fighters evade paying taxes in the United States and that King's promotional firm filed false tax statements.

The Justice Department has probed King's dealings for two years. The investigation began when King's former chief financial officer, Joseph Maffia, filed civil affidavits against King. Maffia agreed to cooperate with the Manhattan U.S. Attorney's office.

King filed a counter complaint against Maffia with New York's Board of Regents, which licenses accountants, blaming Maffia for

any crimes that might have occurred. Maffia was exonerated after an investigation.

In 1967, King was convicted of manslaughter for stomping Sam Garrett to death in Cleveland. King was a bookmaker at the time and Garrett worked for him. King also killed a man in 1954, but the killing was ruled self-defense.

King was also indicted for tax evasion in 1985, but was acquitted. His secretary at the time, Constance Harper, was convicted and served a year in prison.

NFL Trading Deadline Passes Quietly

NEW YORK - As is usually the case, the National Football League trade deadline passed Tuesaday with no major activity.

There was speculation that the Philadelphia Eagles would trade quarterback Randall Cunningham to the Arizona Cardinals a few weeks ago, but that deal did not happen. Cunningham is eligible for free agency after the 1995 season.

Cunningham was benched in favor of backup Rodney Peete before Philadelphia's Oct. 1 game at New Orleans. Peete started and led the Eagles to

victories over New Orleans and Washington over the past two weeks to even the Eagles' record at 3-3.

Peete completed 30-of-45 passes for 256 yards and one touchdown in Philadelphia's 37-34 overtime win over Washington Sunday.

Quarterback Dave Krieg, who was signed as a free agent in the off-season, has led the Cardinals to just one win in six games. He has completed 103of-167 passes for 1,241 yards and six touchdowns, but has been intercepted 10 times.

Buffalo's Andre Reed out with hamstring injury

Buffalo Bills wide receiver Andre Reed could be out for up to six to eight weeks after suffering tears to his right hamstring in the second quarter of last Sunday's game against the New York Jets.

The Buffalo News is reporting Tuesday that Reed's injury will likely sideline him until late November, but the Bills said Monday that an official decision made an unauthorized stadium on Reed's status will be made this week.
