Ironically, it was exactly one year The incident occurred around 5:15 ago to the day that 7-year-old Tony

Bagley was murdered when a gunman opened fire on him and other members of his family as they were trick-or-treating in North Las Vegas.

Reports say that Wright, a student at Faye Herron Elementary School, and his two younger brothers were walking to the home of a family friend, twentyyear-old Anthony Mason, shortly before the incident occurred.

As the youths gathered in front of Mason's house, it was reported that Mason was showing the others a 9 mm semiautomatic handgun when he apparently lost hold of it. It was then that a single shot was fired as Mason attempted to grab hold of the weapon before it hit the ground.

According to authorities, Mason stayed with the victim until police arrived, and could be overheard saying' "it was an accident... I didn't mean for it to

Mason was then taken into custody and questioned, however, no charges have been filed, thus far.

The victim's mother was later taken to the hospital by paramedics after fainting near her son's body.

Responding to Mason's pleas for forgiveness, the victim's grandmother, Marian Frazier, said, "I'm sorry won't bring my grandson back. Why did you have a gun? I'm sorry just isn't good enough."

The family does plan on pressing charges over the incident.

The gun apparently belonged to Mason's mother.

LAS VEGAS—Just four days before "Iron" Mike Tyson's second comeback fight, the former heavyweight champion was forced to pull out citing a fractured

Tyson was scheduled to fight a 10round non-title fight against Buster Mathis, Jr. Saturday night at the MGM

Tyson, 29, said he believes he injured his right thumb more than a month ago while training in Ohio. The thumb later had to be drained. Physicians say Tyson re-injured the thumb earlier this week while training.

"We feel it will probably be another four to six weeks before we could allow him to fight," said physician Gary

After initially calling the injury a 'fake,' Mathis later said: "he's not bluffing. This is real and I hope everything will be allright with him." He went on to say, "I very upset. This was a great opportunity for me. This is what I trained for, both mentally and physically."

For weeks, rumors circulated the former-champ might pull out. During public workouts earlier this week, Tyson appeared in discomfort and wrapped it in a towel after sparring.


"It's a pretty serious setback as far as my continuation on constant fighting," said Tyson. "It's not going to kill me. I'm not hurting for any money or anything. I was really anticipating this fight to go, knowing there was another fight going on down the street. It was going to be a Grand night."

The bout, a Don King Production, planned to be televised live on Fox, was called off, leaving no competition for the highly anticipated Evander Holyfield vs. Riddick Bowe III bout at Caesar's Palace on Pay-Per-View TV.

Had the two heavyweight bouts gone head-to-head, it would have been a first for the sport anywhere in the world.

Tyson, 42-1 with 36 knockouts, was to have been paid \$10 million for the fight. Mathis, 20-0 with two no contests and six wins by knockout, was to receive \$800,000. Tyson's management says Mathis will remain his next opponent.

The MGM Grand did not immediately set a make-up date for the card; reports say it was their decision to postpone the card as opposed to keeping the undercard intact and having a show without the Tyson vs. Mathis bout.
