June 13 — In 1967 Thurgood Marshall was the first Black appointed to the United States Supreme Court.

June 14 — In 1940 President Franklin Roosevelt signed the Selective Service Act allowing Blacks to enter all branches of the United States Armed Forces.

★★★★★

June 15 — In 1877 Henry O. Flipper became the first Black to graduate from a Military Academy in the United States. He graduated from West Point.

★★★★★

June 16 — In 1859 George Goines refused to be ejected from a street car due to racist Jim Crow laws.

★★★★★

June 17 — In 1775 Black soldiers distinguished themselves at the Battle of Bunker Hill. Peter Salem, Cuff Whittemore, Brazilia Lew and Salem Poor were among them.

★★★★★

June 18 — In 1980 the U.S. Senate extended the Black Voting Rights Act for 25 more years.

★★★★★

June 19 — In 1865 Black slaves learned they were free in Texas after the signing of the Emancipation Proclamation in 1863 (two years earlier).
