SILVER STATE GAMES SET TO BEGIN

CARSON CITY - The inaugural Silver State Games, Nevada's Olympic-style sports festival featuring competition in 21 events, will take place July 12-14 in venues throughout the state capital. Organizers are expecting more than 3,500 athletes from throughout the state to participate in the games, the first of its kind in Nevada. Athletes, regardless of age, gender or athletic skill level were invited to compete in 18 Pan American and Olympic sports as well as three recreational activities. The event is sanctioned by the National Congress of State Games and recognized by the U.S. Olympic Committee as the grassroots Olympic sports development program for the state of Nevada.

STRAWBERRY TO PAY BACK CHILD SUPPORT

LOS ANGELES - One day after signing with the New York Yankees, Darryl Strawberry agreed Friday to hand over his \$260,000 signing bonus as partial payment of support owed his ex-wife and children. Strawberry was not in municipal court but his attorney, Milton Grimes, said the ballplayer would have the money ready by Monday. Grimes said Strawberry's one-year deal with the Yankees was key to the settlement, which allowed Strawberry to avoid trial Friday before Los Angeles Municipal Court Commissioner Joseph Biderman. Grimes confirmed that the \$260,000 was Strawberry's signing bonus.

IRVIN SUBPOENAED TO TESTIFY

DALLAS - Defense attorneys attacked a policeman's account of events and officer's evidence-collecting procedures as the felony drug possession trial for Michael Irvin resumed with yet another twist. The Dallas Cowboy receiver was subpoenaed to testify at an examining hearing for former Dallas police officer Johnnie Hernandez, who is accused of trying to hire a hit man to kill Irvin. John H. Read, an attorney for Hernandez, said he wanted Irvin to testify about reported threats against Hernandez's girlfriend, Rachelle Smith. Hernandez and Smith have been subpoenaed as potential witnesses in Irvin's trial.

BARKLEY ACCUSED IN BAR FIGHT

CLEVELAND — Before Phoenix forward Charles Barkley helped Dream Team III beat up on Brazil in Cleveland on Sunday, Jeb Tyler claims Barkley punched him in the nose at a Cleveland Bar, according to police reports. Tyler, 23, of Spencerport, N.Y., filed the complaint early Sunday, accusing Barkley of assault. Barkley in turn filed a report accusing Tyler of using "bodily force" against him. No criminal charges in the case had been filed, as Tyler gave his statement to Cleveland police Monday. Before the incident, Barkley, Reggie Miller and Cleveland Indians slugger Albert Belle had dinner together. Belle was not at the bar where the altercation took place, according to reports. Miller, who was with Barkley at the bar, contends the Suns' star did not provoke the incident.

JOHNSON'S STREAK ENDS AT 21

OSLO, Norway — Frankie Fredericks edged Michael Johnson at the wire Friday evening to win the men's 200 meters at the Bislett Games, snapping the American world champion and world record holder's winning streak of 21 races. Fredericks, a Namibian who missed the world 100-meter record by 0.01 last Wednesday in Lausanne, Switzerland, was timed in 19.82 seconds, 0.03 seconds ahead of Johnson. Johnson, who broke the world 200-meter record with a time of 19.66 in the U.S. Olympic trials two weeks ago, attributed the loss to a bad start. Johnson got back on track Monday, however, winning the 200 at a Grand Prix track meet in Stockholm, Sweden in a time of 19.77, the sixth fastest time ever.

Little change seen in hiring of minorities in baseball

NEW YORK - Minority hiring in major league baseball has changed little in the past seven years, despite promises from owners to improve ethnic

The percentage of blacks working for major league baseball teams has not changed since 1989 and the percentage of women has declined by 3 percent.

Nine percent of front-office employees on the 28 teams are black, major league baseball said recently in releasing its own report — its first report on minority hiring in two years.

Since 1987, when Los Angeles Dodger executive Al Campanis said on national television minorities "lack the necessities" for managerial and executive jobs, the major leagues have been sensitive to racial questions.

underscores the lack of progress in diversifying the game's front offices.

Seven percent are Hispanic, up from 6 percent in 1994 and from 5 percent in 1989. Asian employees have held steady at 2 percent. Minorities comprise 18 percent of the teams' frontoffice staffs, up from 17 percent in 1994 and 15 percent in 1989.

Women in teams' front offices have declined 40 percent from 1992 to 38 percent in 1994 to 35 percent this year.

The percentage of on-field employees who are minorities remained unchanged at 22 percent. Blacks are 8 percent and Hispanics are 11 percent, both unchanged from two years ago. Asians are 1 percent, up half a percentage point.

Baseball's central offices in New York showed slight increases in minority hiring. Blacks have risen from 16 percent in 1994 to 18 percent this year, and Hispanics have However, the report increased from 6 percent to 9

percent. Women declined from 56 percent to 54 percent.

The report shows the total number of people in front offices has declined 2 percent since the start of the players' strike to 2,318. Baseball's central office has cut its staff 29 percent, from 198 to 141, and clubs cut onfield personnel by 6.5 percent to 1,800.

Baseball said its effort to use more minority and female vendors "has encountered many obstacles" and "much room for improvement exists."

Minority vendors increased to 575 from 501 and total dollars increased from \$7.99 million to \$10.71 million. Female vendors decreased from 1,228 to 948 and dollars declined from \$15.92 million to \$14.99 million over the year.

"The volatile labor situation of the past two seasons led to much financial uncertainty and made it nearly impossible to maintain a consistent effort," the report said.
