New Lagos police unit criticized

When the Lagos State government set up a special police unit in 1995 to respond quickly to rising crime, residents heaved a sigh of relief, reports IPS. Lagos State Official statistics show that between 1990 and 1994, 123 police and 276 civilians were killed by armed robbers nationwide. During the same period, 3,613 suspected armed robbers were arrested and 532 killed. Some 7,538 armed robberies were reported during the same period and more than 50 percent of the incidents occurred in Lagos State. Now, a year later, "Operation Sweep" has turned into a nightmare, not just for criminals, but for law-abiding citizens, according to some human rights activists here. According to them, the special squad is also know for rudeness, and members often do not identify themselves to the public. "This is an attempt to harass and intimidate citizens, because nobody can distinguish them from armed robbers. The Nigerian law does not permit people to go about in mufi (civilian clothing) armed," said Tunde Olugboji of the Constitutional Rights Project (CRP), a human rights group.

The World Bank is keeping an eye on a new bill in the Haitian Parliament to privatize state enterprises, as tension mounts in country's financial circles, writes IPS. The legislation, called the "modernization law," would allow the private sector to take over the management and operations of nine enterprises. The legislation would not allow for the outright sale of any of the companies, however - a remedy preferred by Haiti's funders. The bill allows the government to pursue three options in its dealings with the private sector. It can offer concessions, in which private interests are given a lease and criteria for managing a company, and it can offer management contracts. A third option allows private investors to buy a 50percent share and gain management control. Under this option, the dividends of the

(Continued from Page 9) researchers found that 64 cut calories. However, meat still

contains saturated fat even after removing the fat or skin. Saturated fat tends to boost your blood cholesterol levels even more than eating foods containing high levels of cholesterol. That's why you should trim the fat and eat only moderate amounts of meat. Other ways to lower your cholesterol include not smoking, loosing excess weight and getting involved in a regular exercise program. If you lower your cholesterol level two percent, you lower your risk of a heart attack by 30 percent. If you want more information on cholesterol see your doctor. While you're there have your blood cholesterol level checked.

Cholesterol Levels

How's your cholesterol? Fine you say, under 200. That number is only half the information needed to insure good health.

When the doctor gives you your total cholesterol level, you should also be given your HDL and your LDL levels. In a study published in the American Journal of Cardiology

percent of men with cholesterol levels under 200 still had coronary heart problems. The study also found that these men had higher than normal levels of LDLs and lower than normal HDL

A high cholesterol level or a high level of LDLs and/or a low level of HDLs can be main factors contributing to heart attacks, strokes and other circulation

So get your LDL and HDL levels measured when checking your cholesterol levels.

Cholesterol Testing

Cholesterol screening is very important, but there are a few things that can affect the accuracy of your test.

Your position before you take your test will affect your levels. You should sit down before you take your test. Prolonged standing prior to the test can elevate total cholesterol levels an average of 10 percent. You should be seated at least five to 15 minutes before having your blood drawn.

Don't do strenuous exercise for 24 hours because exercise will elevate your HDLs. This will cause an artificially elevated HDL level in your test results.

Alcoholic beverages will elevate HDL, cholesterol and triglycerides thus giving you inaccurate test results. To be safe you should not drink alcoholic beverages 24 hours prior to your taking your test.

You don't have to fast before you take your test and you don't want to change your diet. The object of your cholesterol test is to test typical cholesterol levels. Changing your diet before the test will not give a true indication of your normal levels.

Pregnancy can also elevate your cholesterol levels, especially after the first trimester. We can't tell you not to have a baby, but we would suggest holding off on having a cholesterol test until three months after giving birth.

Before starting your fitness program consult your physician.


