#### KNIGHT DENIES INVOLVEMENT IN SHAKUR'S DEATH

Marion "Suge" Knight, who was sentenced to nine years in prison for a parole violation that took place the night Tupac Shakur was killed has denied allegations that he was involved in Shakur's death. Knight was sentenced to prison for violating a 1995 parole by fighting at the MGM Grand seven hours before Shakur was shot. Knight, the owner of Death Row Records, stated that the rumors that Shakur might have left Death Row were untrue and there was no friction between him and Shakur. According to Knight, police have already questioned the man responsible for the shooting.

#### JERALD JACKSON CLAIMS AUTUMN

Jerald Jackson, an ex-convict who claims that Autumn Jackson is his daughter has asked that she drop her claim that Bill Cosby is her father. Autumn has been free on bail since she was arrested for trying to negotiate a payoff in exchange for silence about her claim that Cosby is her father. Cosby has admitted to having an affair with her mother and has helped pay her educational expenses. But Jerald said he always believed that she is his daughter and her mother used his name on her birth certificate. He suggested Autumn avoid prison at all costs. The program brings more than 25 groups of high school and college students to work camps at four sites (two in Florida, one in Virginia and one in Tennessee) for a week at a time. The students, who come from many races and religions, will live and work in the community and explore some of the issues surrounding the burned churches.

## Marchers seek intervention for Gammage

When will it end?

It is a frequently asked question concerning the trials of police officers involved in

the October 1995 death of black motorist Jonny Gammage. After the acquittal of Brentwood, NewYork, police officer John Vojtas in November of last year and the

mistrial of Baldwin officer Michael Albert and Brentwood Lieutenant Milton Mulholland. the question remained unanswered.

But with final arguments from both the prosecution and defense delivered, the public is awaiting a verdict from Allegheny County judge David R. Cashman.

"The whole thing was a mistake from the beginning," said Dorothy Urquhart of the United Concerned Christians at Work. Urquhart said no trial will be sufficient unless it result in the conviction of all five officers present at the scene of Gammage's death and hopes a second trial will not be held. She believes that the ongoing trial was "opening the wound again" for the Gammage family.

"I cannot see any trial bringing justice," she said.

However, some of Pittsburgh's concerned residents are looking beyond the highly publicized case to Washington, D.C., where they held a "Journey For Justice" to draw national attention to misconduct among city police officers.

Along with a number of other grassroots organizations, UCCW traveled to Washington on Friday, Feb. 21, 1997. The

marchers from Pittsburgh were joined in Washington, D.C. by protesters from Syracuse, Buffalo, Philadelphia and Virginia to deliver a petition to U.S. Attorney General Janet Reno requesting a federal investigation of the Gammage

Gammage, a Syracuse native, died after being stopped for driving erratically along Pittsburgh's Route 51. He was the cousin and business partner of Pittsburgh Steeler Ray Seals.

Tim Stevens, president of the Pittsburgh branch of the NAACP said he hopes to put additional pressure on city, county and national legislators to investigate the Gammage case.

"We're not going to find justice in Pittsburgh, "said Pete Shell of the Campus Coalition for Peace and Justice.

Shell said that county district attorney Bob Colville has never successfully prosecuted police in Pittsburgh.

He feels that Cashman will allow a second trial for Albert and Mulholland, a decision the community support, but whether a second trial will produce closure in Gammage's death is another question.

Stevens said he would not speculate on Cashman's decision. He said the trial has been unpredictable and is "becoming a circus. It's had so many twists and turns it's almost ridiculous."

During a double jeopardy hearing in early February, defense attorneys once again accused deputy district attorney Anthony Krastek of prosecutorial misconduct.

The defense contended that in the first trial, Krastek purposely elicited comments from county coroner Cyril Wecht that caused Cashman to declare a mistrial.

Cashman concluded the hearing without rendering or setting a date for a verdict.
