Reared in San Francisco, she left there in 1988, lured to Las Vegas by its business opportunities. After a stint in the advertising department of a local newspaper, she started her own advertising agency. Working with a client in the wedding business peaked her interest in the industry.

When the previous Plaza Hotel chapel closed, Ali gained the ear of hotel management, with the help of a friend, and successfully pitched her customer-oriented, quality-overquantity premise.

"I can do what any (wedding chapel) on the Strip can do," she said. "I believe a wedding is still a sacred union."

Like Garland, Ali would like to do more black weddings but said she first must increase her visibility among the black consumer. Both owners say they cater to diverse tastes. Garland has 10 full-time ministers including four blacks, four whites and two spanish speakers. Ali contracts with two ministers, one black and one white.

Both also believe marketing is paramount "You must find and actively pursue your market," Ali said.
