

(Continued from Page 6) to purchase a peddler's license from your city's Department of Business Licensing. This license allows you to operate a freestanding business on designated streets (check with them to



are permitted to locate your pushcart business.) If you sell food from your pushcart, you will also have to obtain a foodhandler's license (obtaining this license will require you to pass one or more special tests).

In most cities and towns there are entrepreneurs who have purchased or rented lots that they turn into sites for flea markets or bazaars. Usually they will rent you a space for your pushcart. (You can also rent a lot and set up your own flea market for yourself and other pushcart business owners).

Where you locate your pushcart business is critical. There will be hot competition for the high-traffic spots, so you will need to stake out and secure your location well in advance. If you participate in flea markets, bazaars or outdoor expos, remember that corner spots (spots on the corners of aisles or walkways) usually are the most visible and most desirable.



Be sure to print an ample supply of flyers and business cards - many pushcart vendors lose valuable repeat sales because they do not give customers a follow-up contact number. Developing a traffic chart will enable you to chart your customer base and how many

people pass your pushcart daily.

How much income can you generate from a pushcart business? Pushcarts located within shopping malls like Baltimore's Fanueil Mall or Atlanta's Underground Atlanta can easily generate a sixfigure yearly gross income, according to articles in publications like "Black Enterprise" and "Income Opportunities."

A street-based, pushcart business enterprise may be your ticket to entrepreneurial success, so don't wait. Investigate the possibilities street-based businesses can offer.
