This position will research a variety of detailed documentation and records to determine the amount of license fees owed to begin the delinquent fee collection process. Will contact each delinquent business license payer in person, or by telephone or in writing; explain laws, policies and procedures for the appeal process. Follow established guidelines and Fair Debt Collections Act to prioritize caseload. Prepare and process appropriate documents for non-payment and maintain accurate records and files related to assigned case load. Will follow established license fee guidelines and prepare proper forms to DA Bad Check Collection Unit for processing. **Senior Delinquent Tax/Fee Collector** position will in addition to above also provide lead direction, training and work review to a small group of collectors; organize and assign work, set priorities and follow up to ensure coordination and completion of assigned work.
