So, be calm and kind to the secretary, compliment her. Be calm, controlled and complimentary with the interviewer. But always be discrete and subtle. He or she will get the message.

Use relaxation exercises and take deep breaths to relax yourself so that you do not convey nervousness or a lack of confidence.

Notable mannerisms that nervous interviewees often display are: the inability to look the interviewer in the eye when talking, a discussion of their weaknesses rather than

their strengths, discussion of irrelevant personal issues, crossing of both arms and legs, abrupt and unfriendly responses to questions, playing with objects, touching various parts of one's own body, scratching, and biting the inside of one's lip.

Interviewers might pose situational questions by asking you how you would react to certain situations. So, practice beforehand by creating as many hypothetical problems as you can, and then solve them.

A. It is recommended that mothers nurse their infants for at least 4-6 months, preferably throughout the first year. You should continue to breastfeed even after you introduce solid

It is important to remember that breastfeeding, for any length of time, benefits your baby. Protective qualities lower an infant's risk to illness and lessen the severity of the symptoms should an illness occur. Those protective components continue to benefit an older baby, to some degree, for as long as he or

Q. I have a 14-year-old son who recently decided to become a vegetarian. Should I be concerned about this health?

A. Teens need adequate amounts of protein, iron, calcium, and vitamin B12 in their diets during the body-building years.

Protein can be found in poultry, fish, peanut butter, nuts, seeds, and dried beans.

Iron needs, usually filled by red meats, can be met with dark green vegetables, dried beans, and fruits, as well as by iron-fortified breads and cereals. Some foods rich in vitamin C, such as broccoli, are also good sources.

Calcium, important for strong bones, can be found in dairy products, dark-green leafy vegetables, sunflower seeds, and tofu processed with calcium sulfate.

Make sure your son knows there is more to

the vegetarian lifestyle than eliminating meat. Often professional guidance or reading will help kids select the proper number of servings from milk products, eggs, plant protein, including nuts and legumes, cereals and bread, whole grains, fruits, and vegetables.

Q. I have read that beta carotene is important to your diet. What is it, and where

A. Beta carotene is a naturally occurring substance found in plants. Our bodies convert it into vitamin A. Vitamins are essential for vision, growth, and a healthy immune system. In addition, vitamin A is thought to protect against certain cancers.

Beta carotene can be found in carrots, pumpkin, winter squash, sweet potatoes, tomatoes, greens, apricots, and cantaloupe.

The USDA's Food Guide Pyramid recommends 3-5 servings of vegetables and two to four servings of fruit daily.

Excessive amounts of vitamin A can be toxic. Before taking supplements, check with your physician.

technically insolvent. When developing your cash flow needs, be sure to anticipate holidays and other seasonal events that may impact your business.

Step 4: Determine your break-even point. Your break-even point is the minimum amount of money you need to operate your business each month. Any amount above that will result in profit.

By identifying your break-even point, you

can more accurately track your progress and project future profits. However, keep in mind that this amount will fluctuate throughout the life of your business, so tabulate your breakeven point regularly.
