Denny's again accused of bias

MIAMI — Several state corrections officers have filed a discrimination complaint against Denny's, saying they were turned away twice from one of the chain's restaurants.

The officers from the Everglades Correctional Institution said they were told by a manager that the restaurant had run out of food.

"All he did was lock the door, ask us to leave and say, 'You guys don't look right together," Clifford Fortner, one of the officers, said in The Miami Herald Wednesday.

The nine officers — six black and three white — were told they could call the toll-free number for headquarters in Spartanburg, S.C., Fortner said. They did.

Debbie Atkins, a spokeswoman for Flagstar Companies, Denny's corporate parent, said the company reported the incident to a civil rights monitor assigned to the company since settlement of a 1994 Denny's discrimination case. The monitor is investigating.

"No one in our industry is doing more to address diversity issues than Denny's," Atkins said. "We have come a long way in the area of diversity. We have zero tolerance for discrimination of any type in our company."

Atkins said that the manager, whom she wouldn't identify, had been suspended with pay

over the incident. If the corrections officers' complaint is proved true, the manager will be fired, Atkins said.

The officers said that two weeks ago, the same manager told them that the restaurant's oven was not working.

"We looked around, no one was there and we said they had no reason to lie to us," said Fortner, 33. So they left.

But after the second incident, they began to wonder if it was a racial issue.

In 1994, Denny's settled a \$46 million classaction lawsuit brought by black Secret Service agents and California students who claimed discrimination in separate incidents.

As part of an agreement with the Justice Department, the restaurant chain agreed to retrain employees, feature minorities in its ads and hire an outside lawyer to monitor compliance.

Denny's has 891 company-owned and 716 franchised restaurants nationwide.

At one point, the returns were so low, farmers ere advised to abandon millet and the corns and grow groundnut which had a lucrative export market then. For a time this worked well.

But all these changed with the collapse of commodity prices on the world market. The situation was further compounded by persistent drought and attendant famine which turned the country into a net food importer.

The Third Generation Farming system hopes to reverse all this by popularizing integrated agriculture which targets the local and export

Besides, its advocates believe horticulture

would perform better than any other sector if developed to its full potential.

"Senegal's vocation for agriculture is real. With an annual export of 200,000 tonnes of fruits and vegetables, the horticultural sector would provide much more income (in hard currency) than any other sector of the economy," Seck insisted.

He recalled that the country ranked first in exports of fruits and vegetables among the African, Caribbean and Pacific States (ACP) in the early 1970s.

He admits that this would depend on effective popularization of the scheme among the enlightened youth who have the relative knowhow to apply the new farming techniques.
