some of the most violent battles of the anti-apartheid struggle

Questions about Botha's physical or mental fitness to stand trial have been dismissed by Western Cape Attorney General Frank Kahn, who said Thursday the case would proceed as scheduled.

Last month, two retired doctors submitted sworn statements to the Truth Commission that said Botha was unfit to stand trial due to a stroke he suffered in 1989. That illness led to his ouster as National Party leader and president by F.W. de Klerk, who

presided over the end of apartheid. Dubbed "The Big Crocodile" for his stubborn political style, Botha ruled South Africa for 11 years before being replaced by de Klerk.

Botha's lawyers rejected the doctors' submissions and Kahn decided the trial should go on.

The Truth Commission issued three separate subpoenas asking Botha to appear before it to answer questions about his role in the State Security Council, a body he headed that coordinated the fight against the black liberation movement.

Botha failed to appear, arguing the commission's chairman, the Rev. Desmond Tutu, made a verbal agreement with him in November 1996 that would allow Botha to supply written answers to any commission questions.

Botha has submitted more than 1,700 pages of replies and says the commission is carrying out a witch hunt against whites and wants to humiliate him by forcing him to appear in person.

The trial will take place in George, a tiny tourist town 240 miles east of Cape Town, near Botha's retirement home in Wilderness. Security was tight at Botha's previous court appearances in the case, when he was charged and when he pleaded innocent. Right-wing whites and ANC supporters held demonstrations both times.
