(Continued from Page 1) she gave airport concessions to friends.

He cited a recent report on education in Clark County schools that labeled 13 schools statewide inadequate; of the nine county elementary schools judged "inadequate," four are in District D. Akers didn't comment on how he would fix the problem.

In the matter of lack of growth, he said he would bring federal, state and county officials to work together for solutions alongside community leaders, activists, and businessmen and women.

Akers said District D isn't privy to the growth that's bustling on other parts of the valley.

"As the growth train continues to run through our county, this community, more often than not, is being left at the station,"he said. "What we need is leadership that will work to bring some of the growth to the older parts of Clark County."

Anthony Snowden, who ran against Atkinson Gates in the last election, sided with Akers, saying the commission has neglected her constituents.

"When I ran against Gates, I was fed up with how my community has deteriorated and how she's not accountable and not responsible," he said

Snowden said that after Atkinson Gates took office, "it was like the Jeffersons: 'We're moving on up.' She forgot about her community and the voice of her constituency." Snowden also questioned whether Atkinson Gates will be boon or bust for redistricting, should it be done.

Akers said he would bring federal, state and county officials together with community leaders, activists and the corporate sector to address issues.

He refused to reveal campaign funding sources, saying his contributors are afraid of reprisals. He said he'll be coming out with a list of supporters soon.

Please, if you are pregnant or think you might be, get tested. Give your child, and yourself, hope, and your baby a healthy start in life.

Because all 100 boys received only small, one-time doses of fenfluramine, "it's highly unlikely it would cause any problems," said Dr. Emil Coccaro, a psychiatrist at the Medical College of Pennsylvania who pioneered the use of fenfluramine for

adult brain studies.
