(Continued from Page 3) page letter stating he was "amazed and appalled" by the "unfounded attacks" against Latham by Bell's attorneys.

Jackson said he was doing a "favor" for Bell by having GM authorize Latham to contact Bell. GM is paying Latham to audit the program and mediate its disputes with Black dealers.

Critics claim this dual role is a conflict of interest, a charge

rejected by Latham and GM.

"You owe an apology to me, to Ms. Davenport, and, most importantly, to Mr. Latham," stated Jackson's letter that called Bell's complaints about Latham "despicable."

Jackson's March 20 letter to Bell arrived in an envelope marked: "Personal & Confidential - To Be Opened By Addressee Only."

However, a copy of this private letter from Jackson to Bell was faxed to a number of Black GM dealers on March 24 containing a "W. Latham Shaw Pittman" fax machine imprint.

Further, there are different signatures for Jesse Jackson on the letter sent directly to-Bell and the letter faxed to Black dealers.

Bell sent Jackson a five-

page letter on March 25 asking Jackson how he could support Latham's alleged misconduct, and questioning how Latham obtained a copy of a supposedly confidential letter.

"Are you saying that you agree with Mr. Latham telling me to fire my lawyers ... I just do not believe you would support that kind of advice because you know that would be wrong," Bell stated in his

letter.

"Did you sign my letter, and, if not, who did?" Bell's letter stated. "If this was a personal and confidential letter sent from you to me, how did Mr. Latham get a copy and why has he found it necessary to share the letter with other people?"

Jackson had not responded to Bell's letter at this current press time.

"We're still considering the request," King was quoted as saying in The Atlanta Journal-Constitution earlier this week.

Lawson invited King to speak to striking sanitation workers in Memphis in 1968. It was on that trip that King was shot on the balcony of the Lorraine Motel. Lawson is among those who believe Ray was innocent or acted with help from others.

Lawson met Ray in the mid-1970s and later became his pastor, often visiting and later presiding over Ray's prison marriage. He is now pastor of Holman United Methodist Church in Los Angeles. Though he pleaded guilty to killing King and avoided the death penalty, James Earl Ray recanted. For almost 30 years he maintained his claims of innocence.

Ray's body is to be cremated. Jerry Ray says his brother's remains will be flown to Ireland, where his ancestors were from.
