Troutman still in limbo, while NAACP backs out

The local NAACP appears to be hedging its support for radio personality Bobbie Troutman's show despite throwing its weight behind a forum last month questioning the station's management for putting the show on hiatus.

At the April 29 meeting of the Economic Opportunity Board, the nonprofit entity that runs KCEP FM 88.1, the Clark County educator learned that the Las Vegas branch of the National Association for the Advancement of Colored People withdrew its support for returning to the air "For Women Only." The show was cancelled five months ago to allow for studio renovations, station officials said.

Claude Logan, EOB vice chairman, said someone forged the signature of local NAACP president the Rev. James Rogers on a letter backing Troutman's complaint. Troutman's supporters were ambivalent.

The NAACP's about-face is baffling considering that on Easter, fliers were posted on vehicles touting Troutman and asking supporters to sign a petition to get her back on the air. The NAACP's number was listed for people who wanted to sign the petition. In February, the group and other community organizations sponsored a factfinding meeting where they levied charges against station general manager Sherman Rutledge and questioned why Troutman's show was not on

refusal to let Troutman speak upset many. A motion by Las Vegas City Councilman Gary Reese allowed her to speak.

"You want to talk about honesty and fair play," Troutman said, then "I have to tell my side of the story."

Troutman programming director Louis Conners told her "For Women Only" and "Straight Talk," hosted by City of Las Vegas management analyst Larry Weekly, were going off the air temporarily so that their Studio B facility could be refurbished. Weekly has said he supports Troutman's efforts.

Assemblyman Wendell Williams, D-Nev., said Studio B was up and running when he participated in a talk show last

"We were not in Studio A, we were in Studio B," said Williams, who learned about the renovations from Troutman. "That's kind of strange. I was in there last

Also in Troutman's complaint were allegations that previous general manager Al Johnson abused employees and threatened them with violence.

Troutman said a host of the station's on-air personalities, like DB 2 Short, Kim Bailey, Jack the Rapper, Special K, Galaxy Glen, Regina D and more, were subjected to Rutledge's intimidation tactics.

"A systematic pattern of abuse, neglect and hostile working conditions has occurred at that radio station," Troutman said. "I feel like I'm a scapegoat for many of the ills and problems of KCEP."

Rutledge disagreed, saying, "I think that Bobbie is bitter. She is bitter because she elected to do a character assassination to slander me without any cause or reason."

Rutledge is referring to the community forum on Valentine's Day where he was charged with neglecting his job duties. The situation escalated
