Jefta Dube, in 1997. Dube is now serving a 10-year jail sentence for murdering a former co-worker who he said had taunted him by calling him "Banana's wife." Dube was the first state witness to testify against the former president. He told the high court that at one time he was raped by Banana while he was in a druginduced stupor.

He went on to say that when he resisted his advances, Banana had him detained in cells for three days and later told him that there was nothing he could do about it because as head of state he was above any courts of law.

Dube saidhis ordeal only ended after he sought the intervention of then deputy prime minister Muzenda, who transferred him to the Midlands capital of Gweru.

Muzenda is expected to take the stand and testify that he was visited by Dube who requested permission to be transferred.

Former police commissioners Nguruve and Mukurazhizha, and at least four other senior police officers, will also confirm that Dube complained about being sexually molested by Banana and had requested a transfer.

Another complainant, a cook at the state house, approached Mnangagwa, who was then minister of state security, after he was allegedly sexually abused by Banana.

Mnangagwa is due to appear before the high court to confirm that he received reports from the cook and another complainant, a member of the police protection unit, about the former president's alleged sexual forays.

A gardener, who said he accepted a lift from Banana in his car near the University of Zimbabwe, will call as a witness his employer who will confirm that he reported to him that he was sexually molested by Banana in his office at the campus where the former president was resident professor of theology in 1995.

Consider the racial discrimination in the capital markets and how banks still "redline" by keeping policies that make it tough for African-Americans to get mortgage loans. More than three-fourths of all black small entrepreneurs go out of business within five years, largely because they are undercapitalized from the beginning.

Day-to-day racism can be measured by the cynical policies of tobacco and liquor corporations who design slick advertising campaigns to attract younger black and Hispanic consumers. Day-to-day racism occurs when public transportation systems assign obsolete, older buses and trains to majority-black routes, but place clean, modern transit on routes to the white suburbs.

The old segregation era signs reading "white" and "colored" have been gone for more than a generation. But the practices of white privilege and black exclusion still largely characterize the structure of American society.

Uprooting these patterns of day-to-day racism will require more than a change of laws, but a revolution of values, resources and behaviors.

Government is essential in finding solutions, but a more fundamental cultural transformation must occur in the relations of power. Anything short of that racial revolution will leave in place the policies and processes of racial inequality.

poor families. Two-thirds work while attending college, and 70 percent will need to attend college on a part-time basis at some point.

As Dennis Walcott, president of our affiliate, the New York Urban League, wrote recently, these students should be, not vilified, but celebrated for their "persistence, sacrifice and fortitude" in pursuing achievement.

Walcott noted that the two goals the New York state legislature declared for CUNY —to "maintain and expand its commitment

to academic excellence" and to provide "equal access and opportunity for students, faculty and staff from all ethnic and racial groups and from both sexes"—aren't mutually exclusive.

Remedial courses don't drive these goals further apart. They bring them closer to reality.

As Walcott said, "Our goal should be to build a more inclusive society that supports everyone who wants to compete. If wholesale restrictions are imposed, a door to a better future will be unfairly closed for countless thousands of people. All New York will suffer for it."
