PROJECT SCOPE: THE SITE OF THE WORK IS LOCATED WITHIN AN ALIGNMENT ALONG DESERT INN ROAD, WEST OF HUALAPAI WAY, THEN WESTERLY TO THE SITE OF THE PROPOSED 2975 ZONE SOUTH RESERVOIR. THE PROJECT CONSISTS OF INSTALLING APPROXIMATELY 7,100 LINEAR FEET OF 66-INCH DIAMETER PIPELINE TO SERVE AS THE INLET/OUTLET PIPELINE FOR THE PROPOSED 2975 ZONE SOUTH RESERVOIR.
