dancers. Similarly, Vereen ably brings Billy Flynn to life. He makes great use of his wonderful introduction in a Ziegfeld Follies-like number, complete with fans and adoring female dancers, called "All I Care About."

In the number, Vereen proves that he's the one-man legal dream team of 1920's Chicago. He exudes the razzle-dazzle, smug charm that Flynn requires. Vereen is on the money with his "Johnnie Cochran meets Clarence Darrow" characterization of this would-be superlawyer.

Lemper who portrays Velma Kelly is certainly not outshined by Rivera and Vereen. Lemper's Velma is sleek, tenacious and world-weary. Her strong singing can be high-octane vaudeville style or bluesy tunes with a delightful touch of irony. She performs some phenomenal, sophisticated dance moves that warranted repeated applause.

Without a doubt, Chicago is definitely worth a \$55, \$65 or \$75 ticket. Las Vegas is incredibly lucky to have this exhilarating production and the production's immensely appealing performers. Don't miss it.
