BRATT: HOLLYWOOD UNFAIR TO MINORITIES

NEW YORK (AP) — Actor Benjamin Bratt says Hollywood still has a long way to go to fairly represent minorities. "The idea of fair and equal representation for people of color in this business is a joke," says Bratt, who is of Peruvian and German descent. Bratt and his brother, Peter, have begun producing their own films to bring more minority viewpoints to the screen. One of them, "Follow Me Home," premiered in 1996 at the Sundance Film Festival. Still, Bratt feels pessimistic because "the personification of this industry is an overpampered, self-satisfied middle-aged white male whose only contact with people of color is the people who clean his house." Bratt, who plays a detective on the NBC series "Law & Order," has high praise for girlfriend Julia Roberts, but says dating her has created a paradox. "I'm a man who covets my privacy, and I'm going out with the most famous actress in the world," he says in US magazine's June issue.

COSBY TELLS GRADUATES: MOVE OUT

ORANGEBURG, S.C. (AP) -Speaking to new graduates of Claflin College, Bill Cosby made a plea for beleaguered parents everywhere. "In the name of God move on," Cosby said Saturday. "Because a house can't take three grown people." The actor and comedian sported a Claflin T-shirt and cap, sweatpants and tennis shoes. His wry observations about parenthood drew raucous laughter and applause from both parents and students. "Some of you are going back home and people are not happy," he told graduates of the historically black college. Cosby recalled his college days at Temple University in Philadelphia, where his favorite subjects were political science and philosophy because professors asked questions that no one could answer. One professor wanted to know if a glass was half full or half empty. Cosby returned to class with the wisdom of his grandmother, who told him that "it depends on if you're drinking or pouring."

WINFREY URGES MOREHOUSE **GRADUATES TO PRAY**

ATLANTA (AP) — Oprah Winfrey had some big advice for the dreamers among new Morehouse College grads. "God can dream a bigger dream for you than you can ever dream for yourself," the talk show host told the 470 graduates at the historically black college Sunday. "Real success comes when you learn to act as if everything depends on you, and pray as if everything depends on God." Winfrey established a \$1

million scholarship fund at Morehouse a decade ago and added \$1 million in 1997.

JACKSON FINED IN PLAGIARISM LAWSUIT

ROME (AP) - Michael Jackson, in composing his song "Will You Be There," plagiarized an Italian songwriter, an Italian judge ruled Tuesday. Judge Mario Frigenti immediately suspended a \$2,200 fine but ordered the American pop star to pay court costs, which are likely to be considerable because the case has taken years to progress through the Italian court system, Italian state TV reported. The trial began in 1995, two years after Al Bano, a veteran songwriter and singer, claimed Jackson stole part of the musical motif of his song "I Cigni di Balaka," or "The swans of Balaka," produced in 1987. Jackson's "Dangerous" album, which includes "Will You Be There," dates to 1991. One of Jackson's lawyers, Alberto Seganti, said he will appeal. "There is no proof of plagiarism," the Italian news agency ANSA quoted Seganti as saying. After the verdict was announced, a beaming Al Bano, whose real name is Albano Carrisi, invited Jackson to perform a concert with him and donate the proceeds to children from Kosovo In a hearing in Rome two years ago, Jackson told the court there was some similarity between the two songs "but it's completely coincidental." The court had heard an analysis done by an expert who found that 37 notes were the same in each song. In a separate, civil lawsuit, Jackson's lawyers last year announced that the Italian singer had lost a copyright infringment case against their client and was ordered to pay expenses. The trial that ended Tuesday was a criminal case. In the past, Jackson has been cleared of plagiarism allegations in the United States involving "Dangerous" and "Thriller" albums.

NATALIE COLE TO MISS ST. LUCIA JAZZFEST

CASTRIES, St. Lucia (AP) — Natalie Cole will not appear at the St. Lucia Jazzfest because of damaged vocal cords. She'll be replaced by Erykah Badu, the St. Lucia Tourist Board said last week. Cole, the daughter of the late Nat King Cole, had been warned by doctors to rest her voice for seven to 10 days after a series of performances in Las Vegas. She was to have led the lineup Saturday at an open-air concert on Pigeon Island in the Caribbean. Kool and the Gang, David Sanborn and Nestor Torres are scheduled to perform. Ray Charles, Lionel Ritchie, Patti LaBelle and Deborah Cox have also canceled, some because of scheduling conflicts.
