reportedly discussed the need to review the force's mandate once a peace pact is signed.

African mediators have been working in Lome with representatives of both sides in an all-out effort to take advantage of a cease-fire declared late last month and reach an accord to end an eight-year war that has killed tens of thousands of people. The talks have been hindered by a reluctance on the part of the Sierra Leonean government to

make too many concessions to the rebels, who stand accused by the United Nations and the international community of a horrific campaign of atrocities against civilians in their bid to gain territory.

The rebels have gunned down entire families in the streets and have used machetes to cut off the limbs of others, human rights groups have charged. More than 5,000 people died in fighting in December and January in Freetown, Sierra Leone's coastal capital.
