Waitress accuses Rodman of harassment

LAS VEGAS (AP) — A Las Vegas Hilton cocktail waitress has filed a federal lawsuit against her employer and basketball star Dennis Rodman. Gloria Chapa, 59, claims Rodman pinched and grabbed her breasts while he was seated at a gambling table in June 1998.

She is the fourth woman to accuse Rodman of such an action at the resort last year.

"Hilton tolerates Rodman's behavior because Hilton desires Rodman's business," her lawsuit claims.

In the suit filed last Thursday, Chapa accuses the

resort of "creating an environment of professional segregation, psychological harassment, sexual harass-

ment and intimidation."

She also accuses it of retaliating against women who complain about sexual

harassment.

Hilton spokes-man Alan Hopper declined to comment on the allegations.

according to the most recent Nielsen ratings. "Even though 'African-American History Challenge' had 10,000 viewers, it was only on once a year," he said.

Two other shows that appeal to the African-American market, "Clark County Business Scene," and "On the Move," which both have African-American hosts and are partially sponsored by a local black-owned business and government

entities, will continue to run. Channel 10 is also making a bid to produce Vocal Extravaganza in Black.

The station will continue to carry the national schedule of programs offered by the Public Broadcasting Service, which includes content directed toward a black audience. The shows can get back on the air with community support. Community Matters' annual budget is \$22,578. The history challenge costs \$4,000.

Same day registration is a critical reform. It encourages young people and non-voters to participate by allowing people to register at the poll on Election Day.

The five states that currently allow same day enjoy 15% to 25% higher voter turnout than the rest of the country.

We are also working to challenge other barriers to participation and restructure the presidential debates, ballot access laws and introduce campaign finance reform.
