# Minorities disagree on proposed ward boundaries

"THE TRUTH SHALL SET YOU FREE"

Minorities expressed dismay during a public forum Tuesday on the city's redistricting effort, saying they wished that retired Wisconsin Judge Frederick Kessler involved them more in the process.

Kessler spoke for 90 minutes on the difficulty on redistricting Las Vegas, praising the city as one of the nation's most integrated.

He also highlighted the data he employed in proposing new ward boundaries and discussed the procedures he used in drawing up his plan.

Under Kessler's plan, each ward would have between 76,000 and 79,000 residents. All districts would be majority white. Blacks would comprise 30 percent of the new Ward 5, which encompasses much of Old

Louis Overstreet, African-American Political Action Committee member, said the proposed "turkey head"boundary might not pass legal muster.

West Las Vegas. Hispanics would comprise 25 percent Ward 3, whose representative in Councilman Gary Reese.

The proposed boundaries would take effect Jan. 1,

Until then, several contentious issues will have to be addressed, including settling the issue concerning Fremont Street which was used as a dividing line to separate Wards 3 and 5. Several blacks have advocated removing the turkey head-shaped expanse of Ward 3 land jutting into Ward 5 and containing downtown property south of Fremont Street. Black advocates contend Kesser didn't remain true to his effort

to create "clean cuts" for the wards.

Louis Overstreet, a member of the subcommittee of the African-American Political Action Committee, referred to a 1993 case, Shaw vs. Reno 509 U.S. 630, to back his group's claim that the odd-shaped district be redrawn. The case addressed the need for districts to be contiguous and (See Wards, Page 2)

Keyes' victory came after a stirring speech in which he encouraged delegates to vote their true feelings and not go with Bush just because he's popular.

"If you keep voting for people who are vague on the issues important to this country, you will be defeated

Davis, who is headlining the event, began his musical career in 1968, recording "Turn Back the Hands of Time." In 1978, he recorded a 10-minute version of "Get On Up and Disco" and the ballad "In the Mood."
