than to the state college. I see as dysfunctional a culture fueled by a myth which equates manhood with physical prowess. And how does this pre-modern myth, when personified by role model' athletes, affect impressionable young minds desperate for someone to emulate?

The adolescent black male chooses to imitate the flamboyant misbehavior of celebrity athletes who themselves may be capable of exhibiting considerable brawn, but who are otherwise impotent in American society. Left with no practical outlet for expression of this prowess beyond high school, the hood churns out studs', players' and gangstas' who prey cannibalistically on their own women and children, the primary victims of the black macho persona.

Madison Avenue certainly has all too willingly accelerated this de-evolution, merging the image of the violent criminal with that of the super-athlete, all to the beat of rap music, to galvanize the prevalent stereotype of the black male as the most dangerous animal on the face of the earth, but otherwise superfluous.

The Catch 22 is that it is up to the black community to rescue itself. No mean feat. First, it must acknowledge that a continued denial of the violent behaviors of black males, societal complications aside, is self-destructive. Then, by interpreting said behaviors as symptoms of pathology, it must choose to set about eradicating them.

Where to begin? By valuing black intellect and rewarding academic achievement as much as it has sports. Thus redefined, with an unflagging commitment to truth, intellectual inquiry will invariably lead African-America to a new predominant image of black masculinity.

cases. The supporters of a moratorium are diverse-Democrats and Republicans, liberals, moderates and conservatives. These diverse groups understand that there is no margin for error when it comes to the death penalty. They understand that even one execution of one innocent persons calls into question the integrity of this nation's criminal justice system.

The moratorium movement has suffered some defeats, but it's not down. The Nebraska legislature passed a moratorium bill which was vetoed by the state's governor. Former Governor and Senator Mark Hatfield, also a Republican, is trying to put a measure on the Oregon ballot which would substitute mandatory life sentences instead of the death penalty in that state. As the Presidential election nears, citizens must raise the question of the validity of the death penalty with all the candiates, especially Governor Bush. We must raise the question of wrongful executions with our own governors and our own legislature. We must urge the Governor of Tennessee not to execute a mentally ill person and an innocent one. Every American, of every political ideology, must understand that the foundation of our nation is shaken by the conviction of even one innocent person.
