The Image Awards cemented Hughes' conviction to continue working eight- to 10hour days for the NAACP.

"I knew, but I now I really know, why I am here and why I will continue to assist and support this branch to the best of my ability,"

The NAACP is the oldest and largest civil rights organization in the nation.

Keyes got his victory of sorts in Iowa and did passably well in New Hampshire. But as long as Republicans turn a tin ear to those imploring them to come up with an agenda that taps into the conservative mood of many Blacks, Keyes won't strike a key with Black voters.
