Ebony magazine (April, 1972), Las Vegas had become the "Black Entertainment Capital of the World." At one time in 1971, there were 16 black stars playing at seven major hotels. Sammy Davis, Jr. and Billy Eckstine were at the Sands. Caesar's Palace featured Harry Belafonte and Nancy Wilson. The Flamingo offered Ella Fitzgerald, Hines, Hines and Dad, The Mills Brothers and Sonny Charles. Billy Daniels headlined at the Desert Inn while Redd Foxx starred at the International and Slappy White entertained at the Sahara.

Marion Bennet and Cranford Crawford were elected to the Nevada State Assembly in 1972. Joe Neal, who is now a state senator, won Woodrow Wilson's seat in the assembly that same year. By 1975, Lonie Chaney had also gained a seat in the assembly and Aaron Williams was serving a term on the Clark County Commission.

By 1972 there were seven black school principals and one black assistant superintendent of schools (Claude Perkins), two black judges (Robert Reed and Robert Mullen), one black assemblyman (Woodrow Wilson), one black County Commissioner (Aaron Williams), five black lawyers, three black dentists and two black physicians.

During the decade of the '70s, blacks moved into supervisory and managerial positions in the gaming industry. Perhaps the most well known blacks in the gaming industry were Bob Bailey, then director of the Nevada Economic Development Corporation and Jimmy Gay, ex-assistant manager of the Union Plaza and the states first black mortician. Rod Tanner headed the Nevada Gaming Control Board's Investigation Committee.

Outstanding individuals in the areas of social reform who emerged were David Hoggard, then executive director of the Economic Opportunity Board and Ruby Duncan, executive director of Operation Life Community Development Corporation and former president of the Clark County Economic and Welfare Rights Organization.

In the mid-70s Addeliar Dell Guy served both as a Juvenile Court Judge and a District Judge, heading a list of blacks working in law enforcement and related court-counseling services. By 1979, blacks were close to representational parity in the state's legislature, with 5.7 percent of the population and 5 percent of the representatives.

That same year there were about 417 black teachers and administrators in the Clark County School District constituting about 9.5 percent of its employees including Dr. Claude Perkins, Superintendent of Schools, and Ray Willis, Information Services Coordinator for the school district. Bernice Moulton and Virginia Brewster both sat on the school board and Brenda Mason was the first black on the University of Nevada Board of Regents.

Summary

The history of blacks in Las Vegas is as old as Las Vegas itself. From 1905 to the present they have lived, worked and played here. Before the '30s when segregation arrived, blacks enjoyed equal privileges in what was truly a frontier town.

Segregation arrived in the boom years of the early '30s and solidified during the war years of the early '40s. From 1930 through 1960 Las Vegas was one of the most segregated towns in America. Las Vegas has made many changes travelling toward social and economic equality.

It puts the civil rights movement of the U.S. in the larger context of the struggle for human rights around the world.

It tells the story of the many unknown people who stood up to the powerful forces of evil so that African-Americans would have the opportunity to vote, to eat and drink and be educated along side their white counterparts.

Woolfolk understood that history and worked to make sure that young African-Americans and others would know that history too.

Now, eight years after the opening of the Civil Rights Institute, she can be proud of her contribution to making sure that African-American history of struggle would not be lost.

She understood that the best way to honor black history is to make some and in her case, the making was in the telling. Thanks, Mrs. Woolfolk.
