(Continued from Page 3) said. "We just need the count to get the federal dollars (and) we're just trying to change peoples' views. It's been a full-court press on this one, we want to go in with strong numbers.'

'There's no reason why we shouldn't participate," said Neal. "It's confidential information for the national government to make decisions. It's not information that's going to go to the police, it's going to the census. So there's no reason to be fearful."

Said Anderson: "Wedon't ask for your social security numbers and we don't share this information with any other agencies. We're not looking to tell anyone's business, this if for statistics.

"This is not like voting," warned Arberry, "where you can say, 'Oh, well, I'll just register next time.' This is different. This is it, we've got to be counted now, or it'll be too late to complain when we don't get our fair share."

So, the work continues. And the call, once again, goes out to the African-American community to stand up- or sit if you wish- but in any case, be counted.

"Some community youth groups have volunteered to go out with us this Saturday and go door-to-door to drop off these (census project) information packets," said Weekly. "We'll say, 'it's okay to fill these out." He expects from 75 to 100 people to show up and says anyone else interested in volunteering is encouraged to come.

And, Anderson says those who so desire can still avoid visits to their homes by the census officials, who'll be combing the neighborhoods soon- trying, again, to count the non-respondents that didn't return questionnaires in the first place.
