## Ruffin's 'Southern Exposure' exhibit captivating Tammy D. McMahan

Sentinel-Voice Juxtaposing scenes from his former southern home with abstract views of his new home in the southwest, photographer Kenn Ruffin provides a unique perspective on folk art in his exhibit "Southern Exposure." The photographic exhibit is

featured at the Left of Center Art Gallery and Studio, 2207 W. Gowan Ave, in North Las Vegas. The exhibit opened on April 9 and will continue through June 23.

Southern Exposure is captivating for a number of reasons. First, Ruffin shows that even the ordinary can be art. Ruffin's pieces "Up on the Shelf" and "Rainy Day Stash," which are scenes from a southern kitchen, and "Dixie Fast Food," a snapshot. from a "Mom and Pop" southern grocery store, showcase the simple beauty of the look and the arrangement of jars and bottles on shelves.

Furthermore, when Ruffin turns to the southwest, Las Vegas viewers may be surprised to discover that some of the photographs are of buildings that they pass every day. In that regard, Ruffin transforms photos of the Pueblo Shopping Center on Lake Mead Boulevard and Rampart into pieces of distinctive, abstract art as shown in "Clay I," "Pueblo Villa I," "Pueblo Villa II," "Pueblo Villa III," "Natural Maze" and "Petroglyph Slate I" and "Petroglyph II."

Second, Ruffin's work is evocative. He's adept at creating a sense of place with his pictures of the rural south. The works "Red Clay Road," "Helter Shelter," "Cross Ties," "Trellises," "Mercantile" and "Gulf" transport the viewer to the land of magnolia trees, weatherboard houses, kudzu and country stores.

The scenes from Ruffin's home state of Alabama will likely make southerners and non-southerners recall the emotional memories connected to their homes. The works "Threshold," "Window Box & Faded Fence,""Sunshine Shadow," "Rural Route" and "Pok Salad" convey that undefinable sense of security and history associated with where one is born and raised.


Furthermore, Ruffin's work comes across as pure and natural. The photograph "Grace Emerging from the unstaged portrait of a woman. Without elaborate posing and lighting, Ruffin gives the viewer a glimpse of the day in the life of his mother. The photograph of "Wishing It's believable that the old, broken down well contains and fears of passersby.

Third, Ruffin's work is innovative. His wife Sonya Ruffin stated that "with the use of computers, digital cameras and scanners along with the traditional 35 mm camera and printing process, some of Ruffin's work could very well be a form of high

tech folk art."

The pieces "10:07," "Sundial," and "1:40:47" of Ruffin's mother entitled, illustrate the high tech folk art concept. The photos are Shadows" is a wonderful, pictures of buildings which, through the wonders of computer technology, undergo a metamorphosis to become surreal, monolithic sundials.

When asked about the Well" is honestly poignant. sources of motivation for his work, Ruffin recalled the sometimes difficult mental the heartfelt hopes, dreams and physical journey that he has taken from his native rural Alabama to California to Georgia and, ultimately, to Nevada. In the midst of the hardships Ruffin came to appreciate the art of everyday life. After a life-threatening medical condition impaired his ability to paint, he found (See Ruffin, Page 14)
