squarely because, as the historian Eric Foner wrote in a recent letter to the *New York Times*, "Racial categories, while unscientific, have been used to distribute economic resources and political power in an unequal manner."

That is the past and present that must be faced — and resolved.

That is what some citizens of Mississippi are trying to do in calling for a commission to design a new state flag that all Mississippians can be proud of.

The state's Supreme Court has just ruled that the flag Mississippians have though was their state flag — a banner that includes the Stars and Bars of the Confederacy — was never officially made the state flag.

Thus, the state legislature can vote to design a new one if it wishes.

Of course, this issue is connected to the controversy over whether any state should allow any reference to the Confederacy, America's breakaway evil empire of the past, in its state symbols.

In other words, this is about America's racial past and its present and its future.

Mississippi has a chance to advance that discussion if it follows the notion suggestion by such people as state Senator Johnnie Walls, who is black, and state Attorney General Mike Moore, who is white.

"Why don't we start a positive discussion about what should the state flag of Mississippi look like?" Moore said to the *Jackson (Miss.) Clarion-Ledger*. "Wouldn't that be nice? I guarantee you we would find a lot of commonality of interests in all the communities of our states."

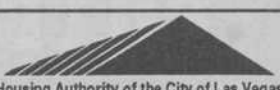
