The Reform Party is disunified. And that is part of its strength, because it accurately reflects the state of the American public — which is filled with conflict over future directions for our own country. The genuinely unifying issue for the Reform Party — it is going to unify -for the independent movement more broadly, and ultimately for the American people, is the issue of creating a new democratic process that promotes developmental dialogue and an environment for a new and everevolving national consensus.

I founded the Committee for a Unified Independent Party, Inc. six years ago, specifically to create a process through which the independents can come together. Anytime you talk to an average voter, they ask you why all the independent parties

don't get together because they'd be so much more powerful if they did.

Of course, people are completely right about this. But the unity of independents, unlike the unity within and between Republicans and Democrats (who are unified with one another in support of globalism), is going to come from the bottom-up, not from the top down. And it comes from the bottom-up as more and more Americans come to see that Democratic and Republican-style "unity" is destroying our democracy and, with it, the capacity of ordinary citizens to govern.

She was shot to death May 28 when a gunman opened fire as she drove away from a fast-food restaurant. Police said the intended target was a childhood friend inside the car who ducked and avoided the bullets.

The Los Angeles Times and Daily News of Los Angeles, citing unidentified police sources, have said the 20-year-old friend is a gang member with a felony record who was wounded by rivals in the same area three weeks earlier.

Police have declined to discuss the investigation or possible gang connections. Lt. Clay Farrell said Friday that "discernible progress" was being made. Parks declined to comment on the case.
