(Continued from Page 11) both in their structural, economic and social form and in the form on xenophobia. Theories of racial inequality are raising their head while at the same time modern communication technologies, especially the Internet, are being perniciously employed to foment racial hatred, xenophobia, and anti-Semitism." In this regard, the Special Rapporteur made a number of recommendations, which have been approved by the General Assembly and the Commission.

These recommendations are: "(a) to convene a world conference on racism, racial discrimination and xenophobia and (b) to consider action at the international level- beginning studies, research and joint action immediately- over the use of the Internet as a vehicle for racist propaganda."

When we discuss racism, we must be clear on this term that is so widely used by so many people.

Through our study groups, over the years, with Dr. Anderson Thompson, we have concluded that racism is "the direct and overall physical and psychological subordination and subjection of one racial group over another for the purpose of maximum political and economic exploitation which is based on the belief (supportable by religious doctrine or scientific data) that either because of heredity (genes, family) or culture (social environment) the dominant race in power is superior to the dominated and powerless race."

The manifestation of racism in the western European world has become institutionalized in a worldwide system of White supremacy.

White supremacy continues to have a devastating impact on African people throughout the world.
