This will be tricky, but he has to confront Sen. John Breaux, a nominal Democrat from Louisiana, who had come to occupy the strategic role between the two parties, voting now with Democrats, then with Republicans. Breaux, a conservative called "moderate," and others could freelance because Daschle could not make them pay a price, as Trent Lott found out by disciplining Jeffords. Now Jeffords, who will organize as part of the Democratic Caucus, will also present a problem of independent vot-

Yet although the narrow party margin invites such behavior, still, I am surprised that Diane Feinstein, a California Democrat whose re-election Blacks strongly boosted, supported the tax cut.

The second big Bush agenda item on the table now is the education program, which has drawn some support from Democrats in the Senate, such as Ted Kennedy and many Democrats in the House, but which also suffers from full funding of programs like

The question is whether now that Democrats can complicate the Bush agenda in the Senate and it is clear that the Bush tax cut

will impoverish the education bill, whether they are able to force Bush to find the funds to include aspects of their agenda.

Bush has no political mandate for this second theft, the theft of public tax funds for private use, because not only did he lose the popular vote, according to the latest CNN/USA Today poll, most Americans (45 percent to 36 percent) think the Senate would be better in the hands of Democrats.

Bush's mantra that government funding is the "people's money" is true, but his statement that they can spend it better than the government is simply false since it depends upon what they want. In any case, these "people" he talks about are not those who need government programs; he means that the wealthy can spend it better, since they don't need government in the first place, and since they see government as a barrier to their wholesale theft of the public

The tragedy is that so many people don't seem to matter that they are being fronted for the rich, as long as the conservative movement holds out the hope that they will be rich or that they will continue to enjoy White privilege.

"All students learned better when placed in diverse classrooms because of the perspectives and it forces individuals to stretch, and to think outside the box," Redwood says. "You compete better when you have had a diverse experience. Employers want people with a sense of cultural diversity, exposure to people with disabilities, and so on because they tend to work better with people overall."

Opponents of race-based admissions policies argue that students who don't qualify

well through admissions testing simply aren't showing enough ability to succeed in the college arena-and that the tests themselves are the leveling factor of the playing

"It's ludicrous to say that a student who has not been given the advanced preparation-such as the exam preparation, the counseling and hours of support to perform

on an SAT-should expect to be on a 'level playing field' and to expect them to do as well as someone who has had that training and support," Sultan says.

"And by the way, what's. the job of an academic institution if not to teach? If someone has a 4.0 and someone else a 3.0, at what point is someone 'not eligible' to learn?"

(Continued from Page 11) The rise in drug-related arrests of Black women in many instances can be directly linked to their entanglement with husbands and boyfriends who were selling or transporting drugs.

The tainted pardons of Marc Rich and Carlos Vignali obscured Clinton's much deserved commutations of the prison sentences of several Black women who had served much longer prison stretches than their male partners.

·Better Prison Care: Women's prisons are hardly country clubs. Many of them are chronically understaffed, and overcrowded.

They suffer from shortages of family planning counselors and services, obstetric and gynecological specialists, drug treatment and child care facilities and transportation funds for family visits.

Also, according to Amnesty International, more than half of women prisoners have children under age 18.

State and federal parental termination laws give child care agencies the power to put children up for adoption who have been in foster care for a prolonged period of time.

Incarceration is a factor

that many childcare workers use to determine whether a mother is fit to care for her children. According to family rights advocates the number of parental termination cases has jumped sharply during the past five years even though in many cases the women who have been released from prison are will-

ing and capable of resuming the care of their children.

The ABA's cure for the glaring gender injustice in the juvenile justice system is for communities to develop alternatives to detention and . incarceration, change in the also author of the book "The biased practices and attitudes of police and judges toward girls, and provide more ser-
