(Continued from Page 9) stantial differences between Blacks and Whites extended to such issues as the degree of discrimination experienced by Blacks, an issue Blacks know much better.

In fact, the same week, another survey on race relations was released by the Gallup organization, which substantiated the differences in Black/White responses.

It illustrated gaping differences of at least 30 percentage points on such issues as whether Blacks were treated fairly in the community in which they lived, whether Blacks were treated fairly in the nation, whether or not Blacks experienced equal access to education and housing opportunities and whether racial profiling of Blacks occurred.

Thus, Julian Bond was

speaking truth-not only as he knew it, but in the sense that he represented the views of the overwhelming portion of the Black community. In doing so, I note with some satisfaction, he took the challenge that I threw down the week before, to measure up to the leadership integrity of a Frederick Douglass who spit in the eye of American celebrations of the Fourth of July as a time when it also honored the practice of slavery.

Bond's assessment set off a great hand-wringing session by the media, which wonder what more Bush could do and whether this will "hurt" the NAACP. Sure enough, Bond (and I do not hesitate to think that this was a coordinated strategy in which Kweisi Mfume was involved) took a risk because access to the White House has always been a staple of the civil rights leaders as a way to prove their legitimacy to lead.

However, such access has become very difficult to obtain in the past two decades when more conservative administrations, hostile to civil rights, have been in the White House. So I'm sure they're thinking, "What is there to lose with Bush?"

I am also sure that Bush's advisers are thinking what does he have to lose if the NAACP pulls his coat. They didn't vote for him anyway? But then, Bush has the responsibility to lead the nation-all of it-and so far, he doesn't seem up to the task.

are just as important as the truth. People see and believe what they want. We have to ask ourselves why are they not getting the message? Perhaps we are not explaining it the right way, and if we cannot explain it well, it may well be we do not fully understand it ourselves.

These are just a few ideas on moving beyond race; there are many more. I don't claim to have all the answers, but the solutions laid out above are steps in the right direction. Working together, honestly and in good faith, will bring us closer to our goal.

(Continued from Page 9) have also left psychological scars on past generations of Black children who American society treated like racial untouchables. Novelist Richard Wright in his memorable essay, "The Ethics of Living Jim Crow," remembers the time he accepted a ride from a "friendly" White man. When the man offered him a drink of whiskey, Wright politely said, "oh no." The man punched him hard in the face and called him a racial epithet. The pain from the blow would pass, but the pain from the word stayed with him forever.

Comedian Richard Pryor understood this. At one time, the irreverent Pryor had practically made a career out of using profanity and racially offensive words, particularly the "N" word, in his routines. But then he had an epiphany. He told a concert audience that he would not use the "N" word, or other racially offensive words again. The audience was stunned. Pryor softly explained that these words were profane and disrespectful. He was dropping them because he had too much pride in Blacks and himself. The audience applauded. Pryor was as good as his word.

Those Blacks who aim intense fire at Lopez should go rent the tape of that concert. They will see why they must aim the same fire at Black entertainers who make a fetish out of using racially degrading words as they do at Lopez.


