Farrakhan. He is getting out early because of being a model prisoner.

Illustrating that this government will thwart any messianic black leader emerging, a federal judge ruled Yahweh couldn't associate or correspond with his followers, because to

do so would be "too great a threat to the community." Yahweh is forbidden to revise his empire.

The temple was given back to the bank in the 1990s, as were the apartment buildings, hotels and other structures. The hotel and
