# Why U.S. won't apologize for slavery

From Aug. 31-Sept. 7, nations, activists and media will gather in Durban, South Africa, for the third United Nations World Conference Against Racism, Racial Discrimination, Xenophobia and Related Intolerance (WCAR).

Already, in the months building up to WCAR, controversy has once again reared its ugly head. The administration of George W. Bush, a.k.a. George II, has threatened to boycott the conference or at worst, send a low-level delegation unless certain planks in the draft documents to WCAR are changed.

The major obstacles to full United States participation are planks equating "Zionism" to "Racism," and another dealing with the issue of viewing slavery as "a crime against humanity." While on the surface U.S. opposition may appear simply political, those privy to inside information realize that in reality America has never feared apologizing for slavery. Instead the fear that has driven it to under-fund WCAR, attempt to derail the conference, and simply wish that it would just go away is none other than the issue of repara-

While ridiculed, laughed at and criticized more than a Black quarterback, quiet as kept-reparations for Africans enslaved in America is no joke. It is a real economic and political minefield for the government of the U.S. as well as many major corporations that benefited from the slave trade, such as Aetna, or the poisonous Ivy Leaguers Yale and Brown Universities, etc...

The ugly side to the whole matter is that by simply acknowledging "slavery as a crime against humanity," the U.S., in the eyes of the international court, sets the legal grounds for reparations to the descendents of the African Holocaust. Any half-literate person around the world, much less the world's top lawyers, understands the frequent use of reparations and its common acceptance by all nations-don't let them fool you.

This whole issue surfaced in an untold way in the halls of Congress during a hearing of the House Committee on International Relations on July 31st of this year. Bringing the issue to the forefront and making hell for the reign of George II was Rep. Cynthia McKinney (D-Ga.), currently by far the most outspoken member of the Congressional Black Caucus.

While questioning William Wood and Steven Wagenseil, two high-ranking State Department officials, on their opposition to draft documents to WCAR, McKinney initiated the following dialogue:

McKinney: Do you object to the characterization of slavery as a crime against humanity?

State Department: Con-

gresswoman, the term crime against humanity is a legal term and in asking that question you are asking me a legal question to which I must give a legal answer.

McKinney: I'd like you to give me a legal answer and you said that eliminating racism was something that was close to your heart? So give me the legal answer and then give me the answer from your heart.

State Department: The legal answer is that there is a new definition for crime against humanity that can include enslavement, but there are other elements and other circumstances, which would render the simple phrase crime against humanity incorrect

The answer from my heart is slavery is a mortal sin against humanity it is possibly the greatest mortal sin because it treats other human beings as property.

McKinney: Sounds to me as if on both accounts, the answer is yes...Is slavery a violation of the laws of civilized nations?

State Department: It is certainly a violation of the law of any nation that I would view as civilized.

McKinney then continues her questioning, "So we kind of agree that slavery was a crime against humanity and is a violation of the laws of civilized nations and so then there only remains the apology. If the state department can go so far as to say 'yeah slavery is wrong...yeah sla-

very violates laws of civilization," so why can't you just take that next leap or just saying I'm sorry?

The officials from the State Department responded slowly. "I think that again the concept of an apology incorporates not simply regret but also the question of reparations for which there is no consensus here in the United States..."

As one of our more popular expressions in the Black community goes, "Whoop, there it is!" Far from its portrayal by White-owned media as a ludicrous idea of Black radicals, it appears that reparations for the victims and descendents of the Maafa (the African Holocaust), makes more than just a little sense.

How serious is the issue of reparations for the victims and descendents of the African Holocaust? Well, since you asked: House Republicans have now threatened to hold up the \$582 million payment the wealthiest nation in the world owes to the UN unless George II signs legislation exempting Americans from the soon-to-be-established International Criminal Court. It will be created in The Hague to prosecute those accused of genocide, war crimes, and guess what else?

"Crimes against Humanity."

Oh well, see you in court. Overstand.
