Local teams perform well in hoops classic

Hoop dreams abounded this weekend in the nation's largest in-season boys' high school basketball tournament. The games were played in the high school gyms at Durango, Foothill, Sierra Vista and Silverado, with the championship games at Green Valley. Participating teams represented 14 states and Canada, with the bulk of entries coming from Nevada. With a record-setting 80 teams, and for the first time, the tournament was played in five separate 16-team tournaments organized by level of competition: the Millennium Cup, Gold Cup, Silver Cup, Bronze Cup and Copper Cup.

Larry McKay, the tournament founder and executive director, felt that by creating the five separate divisions, more schools could participate and would have greater interest in playing against their own level of competition with an opportunity to pick up a championship in the process.

"Our new format has obviously proven incredibly popular and it's really exciting for us to coincidentally have 25 teams from the Silver State help honor the Silver Anniversary of the tournament," said McKay.

Over the past 25 years, the Holiday Prep Classic has turned out a virtual "Who's Who" of NBA talent. Tracy McGrady, Jerry Stackhouse, Baron Davis, Lamar Odom, Rasheed Wallace, Paul Pierce, Ron Mercer, Trajan Langdon, Felipe Lopez and Las Vegas native, Greg Anthony, are all alumni of the tournament

This year's tournament no doubt showcased a few legitimate prospects for the league. There has been considerable NBA chatter about 6-10 center DeAngelo Collins of Inglewood High School, the USA Today Top and Adidas returned as presenting sponsors.

Watson also had an impressive showing at the Holiday Prep Classic, leading the Gaels to the Millennium Cup Championship game.

Other tournament players to keep an eye out for are Jason Obazuaye, a 6-3 shooting guard from Andrew Hill in San Jose, California heading for the University of Colorado; Oumar "Sticks" Sylla, 6-6 forward from Our Saviour New American and Millennium Cup MVP; 6-4 shooting guard Vincent Grier from Bonner Academy in North Carolina heading for NC Charlotte; and Grier's equally impressive teammate, 6-4 forward Fabian Davis, who has verbally committed to Virginia Tech.

In the marquee Millennium Cup title game, Our Saviour New American (New York) jumped out to an early lead, outclassing local powerhouse Bishop Gorman 55-39. The Gold Cup saw Inglewood (Calif.) handle Cheyenne (North Las Vegas) 55-46. The Silver Cup winner was Calvary Chapel (Downey, Calif.), which defeated Chugiak (Alaska) 63-56. The Bronze Cup had Upper St. Clair (Penn.) defeating Mojave (North Las Vegas) 61-53, and the Copper Cup featured two local schools facing each other, as Sierra Vista won over Western 64-54.

In his lawsuit, DiBella said he had nurtured the career of Hopkins for two years, providing financial and other help until the boxer could get his shot at the title.

Ali attends Louisville movie premiere

LOUISVILLE, Ky.- Muhammad Ali shook hands with kids and waved to phototaking fans as he walked up a red carpet and into a theater for a local premiere of "Ali," the new movie that chronicles his life.

Ali was born Cassius Clay in Louisville in 1942. He grew up in the city's predominantly black West End, where Broadway Cinemas is

Wearing a gold turtleneck and black pants under a black checkered jacket, he emerged from a limousine to cheers and flashing cameras. The 59-year-old, who suffers from Parkinson's disease, was helped from the car by his wife, Lonnie, and his longtime friend,

He touched dozens of outstretched hands and took a mock punch at a photographer before bending to hug and kiss a 5-year-old boy on the cheek.

"It's good to be back home," Ali said. Several hundred people attended the event at \$50 per ticket. Proceeds will go to the \$60 million Muhammad Ali Center in downtown Louisville, which will have exhibits focusing on Ali's boxing career and his humanitarian efforts, plus a large lobby and a theater. It's scheduled to be finished in 2004.
