LOS ANGELES (AP) -The story of Rosa Parks won two NAACP Image Awards on Saturday, although the civil rights pioneer shunned the event over its nominations for the film "Barbershop," which features a character making unflattering jokes about her and other black leaders.

CBS' "The Rosa Parks Story" won both its nominations: best TV movie and best TV movie actress for Angela Bassett, who starred as Parks.

"(Parks) wants to thank the NAACP for lifting her up. She wants to thank all of you for loving her," executive producer Willis Edwards, a friend of Parks, said onstage on her behalf.

"She was not happy with what was said about her and she has a right to do that. She has the right not to come," he said backstage, adding he believes she will stay committed to the NAACP despite

Meanwhile, "Barbershop" lost all five nominations, including a supporting actor bid


ment striving to service thousands. Her service includes a population that makes up the city's working poor, homeless, AIDS victims, disabled and the list grows. On March 31st, she will retire.

## Former Compton mayor, officials arrested

### Council members, City Manager face embezzlement charges

three city council members have been arrested on felony embezzlement charges.

Council members Yvonne Arceneaux, Amen Rahh and Delores Zurita, along with


City Manager John Johnson, were arrested after they were indicted by a county grand jury. The exact allegations against the five will not be revealed until the grand jury

indictment is unsealed in

The charges were filed by the county District Attorney's Office, which reportedly has been investigating the alleged misuse of city credit cards for the past three years. The officials were released after posting \$25,000 bail, and ordered to return to Superior Court for a March 24 arraignment, according to Sheriff's Department officials.

Milton Grimes, attorney for Bradley, and Marie F. Alex, the lawyer for Rahh, both declared their clients' innocence at a late-evening press conference last Monday and said they intended to file a motion seeking to recuse the district attorney from the case based on personal involvement. Compton's current Mayor Eric Perrodin is a deputy district attorney.
