His forces killed hundreds of democracy activists in the 1990s, prompting a cutoff of aid from the European Union, United States and other donors.

Those donors made clear going into Sunday's election that he had to allow reform to resume aid.

Eyadema initially pledged to step down in 2003.

Months ahead of the vote, however, Parliament changed the constitution to allow him to seek a new six-year term.

"I didn't choose my political destiny. It was the destiny forced upon me," he said Sunday.

Asked of vote results, he said, "I await the will of God."

Togo's divided opposition fielded several strong candidates, weakening the chance that they will oust him in a single

round of voting.

Top challengers include Bob Akitani, a one-time Togolese independence campaigner, and Eyadema's own cousin, Dahuku Pere.

Akitani was endorsed by Gilchrist Olympio, son of the democratically elected president killed in the 1963 coup.

Eyadema's rivals ridiculed Eyadema's election-day proposal for a national reconciliation government.

Eyadema said the offer would stand, no matter who won. "We are laughing. We don't believe it," Akitani told reporters after voting.

"Eyadema promises a lot, but he's quick to forget. A government of national union in a dictatorial regime? It's a contradiction."
