skin tone, he said.

The results are based on looking for 73 specific markers in the DNA.

The technique has been tried on more than 3,000 DNA samples and "we have not confirmed an error," he

said. A paper describing the technique and its accuracy will be published this month in a forensics journal, he said.

DNA experts said they had never heard of a criminal investigation using a DNA test to determine ancestry. Such tests have not been validated

for use by law enforcement agencies, said Phil Danielson of the University of Denver. Ron Rubocki, director of the University of Nebraska's human DNA identification laboratory, said that he was not familiar with DNAPrint's work, but that the idea of

identifying an ancestral mixture from DNA appears feasible, given the differing frequencies of genetic markers among different populations.

He said it is not clear how much the ancestral mix would actually reveal about a person's appearance.

Proposed Amendment #3 to the FY 2003-2005 Regional Transportation Improvement Program (TIP) and to the FY 2003-2025 Regional Transportation Plan (RTP)

Public Hearing and 30 day comment period

The Regional Transportation Commission of Southern Nevada (RTC), acting as the Metropolitan Planning Organization for urbanized Clark County, is seeking public comment on a proposed amendment to the FY 2003-2005 Regional Transportation Improvement Program (TIP) and the FY 2003-2025 Regional Transportation Plan (RTP). This proposed amendment includes:

Addition of a new project: "Advanced passenger information systems" This project provides for the development and installation of passenger information displays that provide real-time travel and transit operation information at passenger terminals, information kiosks and selected bus stops, as well as a web-based trip planning application. The cost of the project is \$1,137,563 of which 80% will be funded under the Federal Intelligent Transportation Systems (ITS) program.

As required by federal law and the RTC's adopted public participation policy, a 30-day public comment period will open at 8:00am, June 9, 2003. The public is encouraged to submit comments to the RTC in writing at 600 S. Grand Central Parkway, Suite 350, Las Vegas, Nevada 89106-4512 through 5:00pm, July 8, 2003.
