H20 Everywhere

No more is the quote —"water, water everywhere, but not a drop to drink" — more appropriate than Southern Nevada, which is in the midst of its worst drought in a century.

Take rapidly receding Lake Mead water levels, add precipitation that's both sparse and minimal, a glut of water-hogging lawns and a gaggle of water-wasting homeowners and businesses and a drought is virtually assured. That's not even calculating the impact of the 5,000 Valley newcomers each month, all of whom require water to drink, bathe in, use for laundry, etc. Nor do the current outlook factor in future growth in housing starts, construction of new neighborhood casinos, megaresorts and the erection of additional golf courses.

So, yes, we had it coming.

Of course, drastic, drought-plagued times call for drastic measures. As it is, the water Gestapo, a.k.a., the Las Vegas Valley Water District and the Southern Nevada Water Authority, was left with no choice but to hit conservation-be-damned locals with citations and fines. Obviously, few people took "water cop" patrol units seriously. It's common to drive in neighborhoods around the valley or up and down business-lined thoroughfares and see water streaking down sidewalks and puddles in gutters, put there by misalign, broken or badly programmed sprinklers. Maybe the fear of legal repercussions will move folks from inaction to action.

No, the legal recriminations aren't powered by the possibility of criminal prosecution. But you can get hit with a hefty fine, in addition to enduring the tedium of court, missing work, and the embarrassment that comes along with getting in trouble for something so menial. Drastic, but necessary, yes.

The importance of conservation can't be understated. Additional water resources to aid our breakneck growth aren't assured. California doggedly fights to keep its more-than-enough share of Colorado River water and southwestern states continue to haggle over river water allocation.

No one wants to turn on the shower and be greeted with dust or turn on the sink and get drips. While that reality is far away — and likely far-fetched, since water officials would implement even more drastic measures if the situation got that bad — it should serve as a motivator for you to do your part.



Patriot Act II would further rob freedom

Awhile back, I sounded the alarm that the passage of the Patriot Act was designed to capitalize on the fear of Americans following Sept. 11, 2003. Our fear of being victims of acts of terrorism allowed our government to pass this law that in a number of ways violate freedoms of citizens guaranteed under the U.S. Constitution.

I am sure most of you dismissed my alarm as merely a case of crying wolf. Others may have thought I was engaging in a mental exercise akin to debating the proposition if a tree falls in the woods and there is no one around, does it make a sound.
